The Board of Control of the Kentucky High School Athletic Association met at the Phoenix Hotel, Lexington, on October 24, 1940, with all members present.

President C'Donnell called the meeting to order at 8:30 P. M.

President O'Donnell reported that he had been notified by the Oleika Temple of the Shrine that the fall date for the All-Star game was preferable, and that the original request for the change in date was withdrawn.

The secretary read Mr. Potter's report on his football clinics, and recommendations concerning the officials' organization. It was decided to defer action on these recommendations until the annual meeting.

The secretary reported that the officials' organization of the state of Tennessee was not interested in working out a reciprocity agreement for officials between the two states.

The secretary was authorized to make the necessary arrangements for the sites of the basketball clinics, the clinics to begin on December 2, 1940 and end approximately two weeks later.

Matt Sparkman moved, seconded by Russell E. Bridges, that the Courier-Journal be authorized to place on its board for the selection of players for the All-Star game one representative for each athletic conference in the state, the representation being one representative for each ten members or major fraction thereof; that the head football coaches be allowed to ballot for these conference representatives and for the coaches in charge of the All-Star squads as previously; and that the line dividing the eastern and western parts of the state be set at the same place as previously, namely, Highway 31 E, with the three Louisville schools being placed in the western group. The motion was carried unanimously. The secretary was authorized to select the officials for the All-Star game, using whatever method he shall deem advisable after studying the records of the various officials.

John Dotson moved, seconded by W. B. Owen, that all bills as recorded and read by the secretary Bor the period beginning July 1, 1940, and ending October 22, 1940, be allowed. The motion was carried unanimously.

The Board of Control was then called to order in its capacity as the Board of Directors of the K. H. S. A. A. Protection Fund.
