## Board of Control Meeting, December 4-5, 1942

The Board of Control of the Kentucky High School Athletic Association met at the Lafayette Hotel, Lexington, on Friday evening, December 4, 1942.

President Russell E. Bridges called the meeting to order at 7:30 P.M., with all board members present. The minutes of the July meeting were read and approved.

There was a discussion concerning the advisability of conducting clinics for basket-ball officials because of the current transportation problem. John Dotson moved, seconded by J. Matt Sparkman, that the secretary be authorized to set up clinics for basketball officials where requests are made by schools or officials. The motion was carried unanimously.

The secretary reported that the two proposals recently submitted to member schools for a referendum vote had carried, Proposal I by 209 to 61, Proposal II by a vote of

Various board members reported that requests have been made for the Board to alter Tournament Rule 5 referring to the number of games to be played in the regular season by teams participating in district tournaments. H. B. Gray moved, seconded by W. B. Owen, that the following policy of the Board of Control be made a matter of record: The Board of Control of the K. H. S. A. A. does not have authority to alter or waive any provisions of the tournament rules except to carry out the provisions of the recent referendum. The motion was carried unanimously.

John Dotson moved, seconded by H. B. Gray, that the plan for the state tournament be changed to provide that the first rounds and quarter finals by played in four different centers with the regions grouped as follows: Section 1 -- Regions 1, 2, 3, 4; Section 2--Regions 5, 6, 7, 8; Section 3--Regions 9, 10, 15, 16; Section 4--Regions 11, 12, 13, 14. The motion was carried unanimously.

The meeting adjourned to reconvene at 9:00 o'clock Saturday morning, December 5th, with Vice-President W. B. Owen absent from this meeting.

John Dotson moved, seconded by Chris Purdom, that President Bridges by authorized to write State Superintendent John W. Brooker calling his attention to the fact that athletic programs in Kentucky are being curtailed by schools being denied the use of buses for the transportation of athletic teams when the same buses are being used to transport civilians not engaged in defense work, as a result of which our school officials are being severely criticized. The motion was carried unanimously.

Chris Purdom moved, seconded by H. B. Gray, that the Board of Control make no plans to hold state meets in the minor sports, and that it recommend to the delegate assembly that the said meets be discontinued for the duration, and that member schools be urged to continue these sports in their own areas. The motion was carried unanimously.

John Dotson moved, seconded by Chris Purdom, that the secretary be authorized to determine and publish in the magazine an honor roll of coaches and officials who have left their professions and are in the service of their country. The motion was carried unanimously.

Chris Purdom moved, seconded by John Dotson, that the Board of Control allow officials entering the service to retain their last previous ratings as officials when they return to civilian life. The motion was carried unanimously.

Principal D. G. Frisby of the Evarts High School appeared before the Board to give evidence concerning the use of alleged ineligible football players by the Evarts team during the 1942 season. J. Matt Sparkman moved, seconded by H. B. Gray, that Evarts be suspended from date until June 30, 1943 for the use of ineligible players in football during the season of 1942. The vote on the motion was: Bridges, Sanford, Sparkman, Gray, "Aye", with John Dotson not voting.

There was a discussion of the appointment of a Kentucky delegate to the National Federation meeting which is to be held at an early date. The secretary was authorized to name the president of the Coaches Association, the vice-president, or the secretary-treasurer in the order named if he finds that they are still connected with secondary schools.

Chris Purdom moved, seconded by John Dotson, that all bills as recorded and read by the secretary for the period beginning July 1, 1942 and ending November 30th be allowed. The motion was carried unanimously.

The Board of Control was then called to order in its capacity as the Board of Directors of the K. H. S. A. A. Protection Fund.

Chris Purdom moved, seconded by John Dotson, that the following claims against the Protection Fund be allowed:
