Board of Control Meeting - December 17, 1949

The Board of Control of the Kentucky High School Athletic Association met at the Kentucky Hotel, Louisville, on Saturday morning, December 17, 1949.

The meeting was called to order by President Lyman V. Ginger at 9:30 o'clock. Present were Directors Cobb, Gray, Eversole, Arnett and Oakley; Commissioner Theo A. Sanford, Assistant Commissioner J. B. Mansfield, and Mr. Ginger.

James L. Cobb moved, seconded by H. B. Gray, that the reading of the minutes of the October 8th meeting of the Board of Control be waived, since all members of the Board had received copies of the minutes. The motion was carried unanimously.

The Commissioner reported that numerous ties had resulted from the balloting on district representatives and alternates to the 1950 annual meeting of the Association. Roy G. Eversole moved, seconded by James L. Cobb, that the delegates and alternates in the districts where ties existed be determined by lot. The motion was carried unanimously. The Commissioner asked the Board to determine a policy in cases where the person elected to represent a basketball district did not live in the district or was not directly or indirectly connected with a member school in the district. It was the unanimous opinion of the Board that any person who received the largest number of votes sent in by the member schools of any basketball district should represent that district

at the annual meeting of the K. H. S. A. A. regardless of whether the person lived in the district, or was directly or indirectly connected with a school in the district.

The Commissioner reported that his office had sent out the questionnaire on swimming, authorized by the Board in its October meeting, and that the copies of the questionnaire returned indicated that there was enough interest in the "B" classification to warrant the conducting of a State Swimming Meet for this group of schools, as planned by the Board of Control.

The Commissioner discussed the possible current eligibility of Billy Pollock, now enrolled at the Fancy Farm High School and a former student at the Dublin High School, a two-year school. Roy G. Eversole moved, seconded by James L. Gobb, that the Commissioner determine whether or not Dublin has maintained a basketball team during the current school year, and suggested that Billy Pollock be declared eligible at Fancy Farm after he shall have been enrolled there for eighteen or thirty-six school weeks, according to the provisions of K. H. S. A. A. By-Law 6, Section 1. The motion was carried unanimously.

The Board discussed at length the incident which had happened during the Clark County - Inez basketball game, played at Inez on December 10, during which a deputy sheriff had struck official Glen McDowell. All members of the Board thought that Principal Russell Williamson of Inez had done everything that could be expected of him in connection with this case, and recommended that a warning be issued to the school, but that Inez should not be suspended from the K. H. S. A. A. for violation of By-Law 17. In making this recommendation, the Board had in mind the fact that Mr. Williamson had secured the services of numerous peace officers for the game, that he personally assisted in ejecting the troublemaker from the gymnasium, and that he was prompt in seeing to it that a warrant was sworn out for the person involved.

James L. Cobb moved, seconded by C. H. Arnett, that all bills of the Association for the period beginning October 8 and ending December 16 be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as the Board of Directors of the K. H. S. A. A Protection Fund.

Secretary-Treasurer Theo. A. Sanford of the Protection Fund asked the directors to set a maximum figure which would be paid on certain unscheduled injuries and claims for extra-ordinarily large amounts, when the maximum of 40% or less, voted by the directors in the October meeting, is applied. C. H. Arnett moved, seconded by Carlos Oakley, that \$100.00 be set as the maximum figure for the type of claims mentioned by the Secretary-Treasurer. The motion was carried unanimously.

The Secretary-Treasurer reported that he had received a claim from Supt. R. E. Davis of the Carlisle High School, on behalf of Noel Williams, who had developed osteomyelitis in his leg from an injury received in football practice, resulting from a bruise. It was stated that this injury, which amounted to \$230.73, came under the heading of unscheduled injuries. The Secretary-Treasurer stated that he had been unable to find out from Dr. W. B. Brown of Lexington whether or not the injury had resulted from an old injury. James L. Cobb moved, seconded by Carlos Oakley, that the amount of the settlement on behalf of Noel Williams be left to the judgment of the Secretary-Treasurer, pending the receipt of the additional information from the doctor involved. The motion was carried unanimously.

H. B. Gray moved, seconded by Carlos Oakley, that the following claims against the K. H. S. A.A. Protection Fund be allowed:
