

The Board of Control of the Kentucky High School Athletic Association met at the K.H.S.A.A. Building, Lexington, on Saturday morning, February 2, 1957. The meeting was called to order by President Russell Williamson at 10:00, with Vice-President Louis Litchfield; Directors W. H. Crowds, W. B. Jones, K. G. Gillaspie, Jack Dawson, and Cecil A. Thornton; Commissioner Theo. A. Sanford and Assistant Commissioner J. B. Mansfield present.

Louis Litchfield moved, seconded by W. H. Crowds, that the reading of the minutes of the December meeting be waived, since the members of the Board had received copies of these minutes. The motion was carried unanimously.

The Commissioner reported that he had been unable to get the final recommendations of Swimming Committee Chairman Alfred M. Reece, but that Mr. Reece would poll members of the committee regarding certain changes in the 1957 regulations for the State Swimming Meet, including a recommendation that Classes B and C meet in Lexington on Saturday, March 30, Class A on April 6. W. B. Jones moved, seconded by W. H. Crowds, that the Board of Control accept the recommendations of the Swimming Committee regarding 1957 regulations for the State Swimming Meet. The motion was carried unanimously.

J. B. Mansfield gave a report on the meeting of the National Federation Football Committee and of the state association executive secretaries, held in Chicago on January 3-5. Mr. Mansfield represented the Association at both meetings, and President Edgar McNabb and Secretary Joe Ohr of the Kentucky High School Coaches Association attended the football sessions.

The Board approved the usual invitation to the K.H.S.A.A. dinner meeting, scheduled to be held in Louisville on Friday, April 12, and authorized the Commissioner to send two complimentary tickets to each member school upon request. Commissioner Sanford and Director Jones were authorized to continue their search for a speaker at the dinner.

The Commissioner reported a good advance sale of State Tournament tickets, and brought several tournament items to the attention of the Board.

W. B. Jones moved, seconded by Louis Litchfield, that the following regulations concerning fees for regional tournament officials be adopted: The official shall receive a fee of \$20.00 per game and a transportation allowance of 7¢ per mile for all necessary travel. In the event it is necessary for the official to remain overnight at the tournament site, he shall be paid an additional \$10.00 per day for lodging and meals. An exception shall be made for Region 7, which will have only four teams in its regional tournament. The motion was carried unanimously.

K. G. Gillaspie moved, seconded by Jack Dawson, that the State Track Meet be held in Lexington on May 17-18, and that the Commissioner be authorized to set the dates and determine the sites of the other spring events. The motion was carried unanimously.

The Commissioner reported that he and President Williamson had broken ties in the balloting for basketball tournament sites in Districts 6, 21, and 38, in favor of the Trigg County High School, the Lebanon High School, and the Augusta High School, respectively. Jack Dawson moved, seconded by Cecil A. Thornton, that the action of the President and Commissioner be confirmed. The motion was carried unanimously.

W. B. Jones moved, seconded by Jack Dawson, that all bills of the Association, beginning December 22, 1956, and ending February 1, 1957, be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as Board of Directors of the K.H.S.A.A. Protection Fund.

Chairman W. H. Crowdus of the Insurance Committee stated that his committee had met the preceding afternoon, February 1, with several representatives of commercial insurance companies, and that these representatives had been given certain information concerning the K.H.S.A.A. Protection Fund, services now offered, improvements desired, etc. Mr. Crowdus stated that the committee was continuing its study, and that it would make reports of its findings at subsequent Board meetings. He was not sure whether or not any recommendations would be forthcoming prior to the April meeting.

Secretary-Treasurer Sanford presented a list of claims which had been paid since December 22, 1956, the total amount of these claims being \$4,019.69. Cecil A. Thornton moved, seconded by W.B. Jones, that the claims as presented by the Secretary-Treasurer of the Protection Fund be allowed, and that a list of the claims be made a part of the minutes of the meeting. ^{The motion was carried.} The claims are as follows:
