

WEST ELIGIBILITY COMMITTEE

SEPTEMBER 5, 1989

The West Eligibility Committee of the Kentucky High School Athletic Association met at the Holiday Inn North in Elizabethtown, Kentucky, on Tuesday, September 5, 1989, for the purpose of hearing appeals. Members present were: Chairman, Huston DeHaven, Sam Chandler, C.K. Henry and Charlie Miller. Tom Mills and Billy V. Wise were also in attendance.

Principal Blake Haselton, Oldham County High School and Mr. and Mrs. Christopher Spires appeared before the Committee to appeal the ruling in the case of Roy Huff. Roy had been declared ineligible under the provisions of the transfer rule. Following the presentation, questions by members of the Committee, and a lengthy discussion thereof, Sam Chandler moved that By-Law 6, Transfer Rule, be waived in this case. C.K. Henry seconded the motion and it passed unanimously.

Bradley N. Terhune came before the Committee to appeal the ruling of the Commissioner following his transfer to Hopkinsville High School from University Heights Academy. Brad was accompanied by his mother and Mr. Don Kemp. Following the presentation by Mr. Kemp and questions by members of the Committee to Mrs. Terhune and Bradley, C. K. Henry moved, seconded by Charlie Miller that By-Law 6, Transfer Rule, be waived in this case. The motion passed unanimously.

Mr. James D. Cochran, Sr., then appeared before the Committee to appeal the ruling of the Commissioner on behalf of his daughter, Annie Jo Cochran. Annie Jo had been declared ineligible to represent Western High School in interscholastic athletics following her transfer from Holy Cross High School. Following the presentation and a discussion thereof, Sam Chandler moved, seconded by C.K. Henry that By-Law 6, Transfer Rule, be waived in this case. The motion passed by a vote of 3-1.

Then came Mr. Martin Schiller, his wife, Patti and son, Adam, to appeal the ruling of the Commissioner following Adam's transfer to St. Francis High School from Eastern High School. Following the presentation, Sam Chandler moved, seconded by C. K. Henry, that the decision of the Commissioner be upheld in this case. The motion passed unanimously.

Coach Joe Lewis, accompanied by Tim Snodgrass, came before the Committee to appeal the ruling of the Commissioner following Tim's transfer from Paducah Tilghman High School to Reidland High School. Following their presentation and a discussion thereof, Sam Chandler moved, seconded by Charlie Miller, that By-Law 6, be waived in this case. The motion passed by a vote of 2-1.

Principal Gene Brooks, Marshall County High School, appeared before the Committee to appeal the ruling of the Commissioner in the case of Jeff Sewell. Jeff was ruled ineligible following his transfer to Marshall County High School from Lyon County High School. Upon completion of Mr. Brooks presentation and a discussion thereof, Charlie Miller moved, seconded by C. K. Henry, that By-Law 6 be waived in this case. The motion passed unanimously.

Mr. and Mrs. Rogers Aldridge then appeared before the Committee on behalf of Mike W. Stohoff. Mike was ruled ineligible following his transfer from Fairdale High School to Doss High School. Following the presentation and a lengthy discussion thereof, Charlie Miller moved, seconded by C.K. Henry, that By-Law 6, be waived in this case. The motion failed by a vote of 2 for and 2 against.

Mr. Jim Brummal appeared before the Committee to request a waiver of By-Law 6, in favor of his son, Clay Brummal, to permit him to play football for Fulton City High School. Clay had transferred from Hickman County High School, a school where football was not offered. Following Mr. Brummal's presentation, C.K. Henry moved, seconded by
