**The Board convened on Wednesday, February 21, at 8:00 a.m. and recessed Into Work Session.**

**The Board reconvened at 12:40 p.m.**

**Pledge of Allegiance** – Board member Kirby Smith led the Pledge of Allegiance

**Reflection** - Darrell Billings used a Dwight Eisenhower quote that he looks at every day concerning integrity, vision, courage and understanding. The impact of high school athletics seems apparent in that school shooters going back to Columbine, were not involved in athletics. ### **The Board Recessed into Work Session (Chaired by President-Elect Donna Bumps)**

During the work session, the Board discussed the various items on the work session agenda. Those considered with no action were:

#### **Set Basketball State Dates and Sites, 2018-2019 to 2021-2022**

In November, the Board of Control established the dates for the 2020-2021 basketball season, a step necessitated by Rupp Arena hosting the 2021 NCAA Men's First and Second Round Division I tournament.

The KHSAA then reviewed the schedule for the upcoming four seasons with the arena and made the following determinations:

- For 2019, the KHSAA already has held the weeks of March 5-10, and March 12-17 to include move-in;
- For 2020, the KHSAA has the weeks of March 10-15 and March 17-22 to include move-in;
- For 2021, the KHSAA has March 2-7 and March 9-14. March 17-22 is not available due to prior Rupp commitments (NCAA);
- For 2022, the KHSAA has March 8-13 and March 15-20 to include move-in.

Looking at the schedule for the next four years, there are conflicts in dates held for the KHSAA with the SEC (and ACC events). Previously, the Board has stated that it did not want the boys' state basketball tournament to conflict with the SEC or ACC Men's Conference tournaments.

Those SEC dates for the next few years are (with ACC dates on a similar schedule)-

- March 13-17, 2019, Bridgestone Arena, Nashville, TN
- March 11-15, 2020, Bridgestone Arena, Nashville, TN
- March 10-14, 2021, Bridgestone Arena, Nashville, TN
- March 9-13, 2022, Amalie Arena, Tampa, FL
- March 8-12, 2023, Bridgestone Arena, Nashville, TN
- March 13-17, 2024, Bridgestone Arena, Nashville, TN
- March 12-16, 2025, Bridgestone Arena, Nashville, TN

Following review, Staff compiled a comparison of available dates. Based on the review, and with the history of prior rotation of the state tournaments, and with the best interests of the Association at the root of the decision, the following recommendation of the state schedule for basketball for 2019 to 2022 was made:

- March 17-22, 2020 (BOYS)

- March 16-21, 2021 (RUPP NOT AVAILABLE)
- March 8-13, 2022 (GIRLS) (SEC Tampa)
- March 15-20, 2022 (BOYS)

#### **Football Alignment Draft Discussion, Feedback and Adoption**

At its January Meeting, the Board approved the distribution of the enrollment numbers for KHSAA football schools and the opportunity to play into a higher class. The results of that information were provided including planning maps used for placement of teams.

Each class was then discussed with request for approval to distribute the draft alignment following any suggested amendments by the Board.

**Potential Changes, 2019 and Beyond, BA and FP formats (and potentially, sites)**

The Commissioner brought several discussion points for the Board with the end of venue obligation of the KHSAA to its state tournaments in baseball and softball.

After considerable discussion, it appears clear that the Board could take advantage of this opportunity to revise the structure of both events. In addition to what may be perceived as deficiencies in softball, the issue of pitch count and pitching limitations has created a situation that makes the state baseball tournament extend over two weekends in order to provide equity between the membership.

These issues could be addressed with simple format revisions. One alternative is to create an eight-team, single-elimination, state tournament in both sports. Such change would require the implementation of a semi-state game in between the regions and existing state dates. This change would also allow for the championship in baseball to be completed one week earlier than is currently the case.

This change would also address frequently expressed concerns by school administrators about the amount of time between the end of school and the completion of the baseball tournament. The lateness of the completion of the baseball season also generates concerns from parents, participants and coaches because of the delay in the onset of summer vacations, summer jobs, and potentially other involvement with sports in other levels.

The rotation could be developed similar to the existing soccer brackets, and the former baseball brackets within the state, that would allow for a single game to be played to qualify teams for the state tournament. The financial model that was utilized for baseball in the past and for soccer currently could easily be implemented for those semistate games, where the officials and trophies are deducted from any gate. Revenue and the resultant money is divided between the participating teams, the host, and the KHSAA, which would replace the minimal amount of lost revenue for the association for the current first round of the state. Team expenses would obviously need to be limited solely to mileage, but it should be extremely workable in both sport.

Mr. Tackett further pointed out that it is critical to discuss this now because of the need to be sure that we are out of the way from spring testing and other activities. It appears that schools are going to consistently end on or near their planned dates, because of the variety of ways in which missed days can now be made up. For scheduling and other reasons, this is the ideal time to make a change in format. It is also relevant because the association is up for renewal of its contract in baseball, and is due to submit an RFP for hosting softball.

### **Review International Tie Breaker Softball Data**

Commissioner Tackett asked the Board to review its decision from May, 2017 to implement the international tie-breaker.

For several years, Staff has been very concerned at the State softball tournament with the number of games being pitched by certain pitchers, and the number of games being caught by certain catchers.

During the 2015-16 school year, discussions began about a potential change in the state format. Trying to play a double elimination tournament in a two-day format does increase the problem of overuse. For that reason, the format was changed for the tournament to play a round of the tournament on Thursday night. This allowed fewer games to be played on Saturday by backing up at least one round to Friday.

The problem is not just pitching alone. The problem occurs with catching and the gear required and seems to be further compounded by the heat situation where the tournament is played. A change in the tournament format appeared to be a strategy for lessening the risk of overuse of the players, and the risk of heat-related problems among the players.

At the same time, two years ago, Staff began reviewing the length of games and various measures to ensure that games did not go a length of time that would place players at greater risk. Within the competition rules of the KHSAA, there was already a requirement for the regular season that games use what was commonly referred to as the international tiebreaker (ITB). In this procedure, a runner is placed on second base to start an inning. Admittedly, this changes the entire strategy of the game.

Within the competition rules, this International Tiebreaker was to be used in the 10th inning and beyond, and could be used by coaches with mutual agreement in the eighth and ninth innings. This became a possible avenue to make sure that in the extreme competition circumstances of the postseason and the extreme heat that can come the first part of June in our state, these extremely long games would seldom be played.

The Board approved the issuance of a survey of the member schools. That survey was conducted in April of 2017 and distributed to the principals and athletic directors of the member schools, per Bylaw 1. Bylaw 1 states that the principal is responsible for the school and may designate an official person to serve as the designated representative to vote on all matters. The bylaw does not allow coaches to cast a vote. However, when the survey was distributed, Assistant Commissioner Darren Bilberry distributed an email to all 790 softball coaches on record seeking feedback on the issue. This list is extremely accurate as this is the last from which compliance with KRS 160.445 is determined, as well as rules clinic attendance being monitored.

The survey resulted in a 53% of affirmative vote in favor of implementing the ITB for all games, and 13% had no preference. Additionally, only 33% opposed such implementation. That was the recorded vote when the membership had an option. Of the 240 softball playing schools, 220 responded to the survey, a great response.

There was discussion on the tournament format (single vs double elimination) and use of the ITB. With the 2018 playing season, the contracted obligation to its current site has ended, and it is time

to submit an RFP to interested cities. Prior to the submission of an RFP, the format of the tournament must be determined. The cities must know if 31 games over three days are still there for potential housing for 16 games and all of the things that go with playing the current tournament format. Interested parties also would want to know if the tournament is being cut by a number of teams and other aspects of the event.

If a decision is made to alter the format of the tournament, it is likely that much of the necessity of the international tiebreaker simply fades away.

### **Cheer Postseason Structure**

Commissioner Tackett and Associate Commissioner Cope reported on ongoing revisions in the Competitive Cheer program. After five years, revisions are necessary to both contain costs and ensure the quality of the programming. The transition to a partnership with Varsity Brands (UCA) has been very good, but as schools and the KHSAA carefully monitor and manage costs, additional changes are needed.

The Commissioner and Staff recommended the combining of regional competitions. This would help address the continued concern of automatic qualifiers. In addition, the planned regional competition will be held on two standard rotations releasing a weekend when ACT tests were administered.

Game Day would now be a division at region and State and Coed, due to the lack of participation, would be combined to one division.

With these proposed changes, the State Competition would be a single day event. Additionally it was recommended that the State date be for Saturday December 8, 2018 at Alltech Arena.
