Board of Control Meeting - April 17, 1947

The Board of Control of the Kentucky High School Athletic Association met at the Kentucky Hotel, Louisville, on Friday, April 17, 1947, at 10:45 A.M.

President Bridges called the meeting to order with all members present.

Coach Kimmel, representing Principal Davis of Manual, appeared before the Board to discuss the eligibility of Cornelius Curry. Lyman Ginger moved, seconded by Sam Pollock, that the Board sustain the ruling of President Bridges on the eligibility of Cornelius Curry. The motion was carried unanimously. Prin. J. B. Moore of Madison Central,

Principal Hise Tudor, Coach James Art, Mrs. Fay Ward Little, Mrs. Ward, and P.T. A. President Lloyd Woods, all of Paint Lick, appeared before the Board requesting that the period of suspension of the Paint Lick and Central schools recently set by the Board of Control, be shortened. Action on this request was taken later.

Principal F. D. Wilkinson of Frankfort, and Supt. George Yates and Principal Joe Sabel of Versailles appeared before the Board to discuss the trouble which had arisen during and following the Versailles-Frankfort basketball game played on February 14. After these school representatives had retired, there was a lengthy discussion of the Frankfort-Versailles case, and also of the Paint Lick-Madison Central suspension. Lyman Ginger moved, seconded by Theo. A. Sanford, that Frankfort, Versailles, Paint Lick, and Madison Central schools be suspended from date until September 1, 1947, for violation of By-Law XXXV, and that all of these schools be placed on probation for the school year 1947-48. The motion was carried unanimously.

The secretary stated that he had received a letter from the Principal of the Kentucky School for the Blind relative to the membership of his school in the Association. It appeared that this school has a wrestling team and that this team could not compete against wrestling teams in other states representing schools which are members of Athletic Associations. Lyman Ginger moved, seconded by Sam Pollock, that the Kentucky School for the Blind be declared eligible for membership in the K. H. S. A. A. The motion was carried unanimously.

Lyman Ginger moved, seconded by T. K. Stone, that Nelle Sanford be allowed \$250.00 for clerical services which she performed in handling passes and tickets in connection with the recent State High School Basketball Tournament. The motion was carried unanimously.

Sam Pollock moved, seconded by Lyman Ginger, that all bills as recorded and read by the secretary for the period beginning March 22, 1947, and ending April 16, 1947, be allowed. The motion was carried unanimously.

Sam Pollock moved, seconded by T. K. Stone, that the tentative date for the State Track Meet at Lexington be May 30, that the State Baseball Tournament be held in Louisville during the second week in June, and that the State Tennis and Golf tournaments be held at Bellevue and Ft. Knox respectively, the dates to be determined by the secretary. The motion was carried unanimously.

The Board of Control was then called to order in its capacity as directors of the K. H. S. A. A. Protection Fund.

T. K. Stone moved, seconded by Lyman Ginger, that the following claims against the Protection Fund be allowed:
