The Board of Control of the Kentucky High School Athletic Association met at the Phoenix Hotel, Lexington, on Friday morning, March 18, 1955.

The meeting was called to order by President Carlos Oakley at 10:00, with all Board members and Commissioner Theo. A. Sanford present.

Louis Litchfield moved, seconded by Jack Dawson, that the reading of the minutes of the February meeting be waived, since the members of the Board had received copies of these minutes. The motion was carried unanimously.

The Commissioner reported that sewer lines for the new building had been completed, that the basement excavation had been made, and that work on the building was progressing very well.

The Commissioner reported that he had sold the television rights for the final session of the State Basketball Tournament to WLEX-TV for \$1,000.00, after having determined that this session was a sellout.

Louis Litchfield moved, seconded by James L. Cobb, that President Oakley be asked to present the trophies and awards at the end of the final session of the tournament. The motion was carried unanimously.

W. B. Jones moved, seconded by Jack Dawson, that all bills of the Association for the period beginning February 25, 1955 and ending March 17, 1955 be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as Board of Directors of the K.H.S.A.A. Protection Fund.

Louis Litchfield moved, seconded by W. H.
