

Board of Control Meeting -- April 13, 1956

The Board of Control of the Kentucky High School Athletic Association met at the Kentucky Hotel, Louisville, on Friday morning, April 13, 1956.

The meeting was called to order by President Williamson at 9:30, with all Board members, Commissioner Theo. A. Sanford, and Assistant Commissioner J. B. Mansfield present.

W. H. Crowdus moved, seconded by Roy G. Eversole, that the reading of the minutes of the March meeting be waived, since the members of the Board had received copies of these minutes. The motion was carried unanimously.

The Commissioner gave a brief report on the recent State High School Basketball Tournament, indicating that a new record had been set in receipts and attendance. He indicated that total receipts would be in excess of \$113,000.00, and that profit to the Association should be approximately \$88,000.00.

Director W. B. Jones presented a letter from the manager of the Cumberland Falls State Park, confirming Board of Control reservations during the period of July 26-28, this being the time of the Board of Control summer meeting.

There was a general discussion of the proposals which were to be submitted to the forthcoming K.H.S.A.A. Delegate Assembly.

There was a discussion of possible re-districting in Regions 8, 10, 11, 14, and 16. W. H. Crowdus moved, seconded by Louis Litchfield, that President Williamson, Vice-President Eversole, and Directors Dawson, Gillaspie, and Jones be authorized to work out possible basketball re-districting, with the understanding that their recommendations will be approved in a subsequent meeting of the Board of Control. The motion was carried unanimously.

President Russell Williamson and Director W. B. Jones were named Delegate and Alternate respectively to the summer meeting of the National Federation.

W. B. Jones moved, seconded by Roy G. Eversole, that President Williamson be authorized to call a Board meeting when the State Basketball Tournament Site Survey Committee is ready to make its report. The motion was carried unanimously.

Roy G. Eversole moved, seconded by K. G. Gillaspie, that all bills of the Association, beginning March 16, 1956, and ending April 12, 1956, be allowed. The motion was carried unanimously.

The Board was then called to order in its capacity as Board of Directors of the K.H.S.A.A. Protection Fund.

Secretary-Treasurer Sanford recommended that the same Protection Fund fees and benefits be set for 1956-57 as were used in 1955-56; and that each member school of the K.H.S.A.A. insuring its athletes in the Protection Fund for 1956-57 be given a dividend credit of \$30.00. W. B. Jones moved, seconded by Roy G. Eversole, that the recommendations of the Secretary-Treasurer for 1956-57 be accepted and put into effect. The motion was carried unanimously.

Secretary-Treasurer Sanford presented a list of claims which had been paid since March 16, 1956, the total amount of these claims being \$1,510.57. Roy G. Eversole moved, seconded by K. G. Gillaspie, that the claims as presented by the

Secretary-Treasurer of the Protection Fund be allowed, and that a list of these claims be made a part of the minutes of the meeting. <sup>The motion was carried.</sup> The claims are as follows:
