

The KHSAA Board of Control met in Lexington at the KHSAA Office Building on Monday, April 17, 1995, for the purpose of hearing eligibility appeals. Mr. Frank Cardwell, President, called the meeting to order at 9:15 a.m. Other members present were Tom Bryant, Tasso Harris, Cookie Henson, Claudia Hicks, Teresa Isaac, Ozz Jackson, Wendell Thomas and Frank Welch. Members absent were Bill Beasley, Ken Cox, Kathy Hopper, Bob Rogers, Stan Steidel and Grant Talbott. Also present were Commissioner Louis Stout, Exec. Asst. Comm. Brigid DeVries, Bus. Aff. Mgr. Julian Tackett, S.I.D. Brooks Downing, Ken Tippet, Board Attorney Danny Reeves, Randy Kimbrough and Collette Anderson of the State Department of Education and George Barker.

Prior to each appeal, Mr. Cardwell explained to the appellants the procedure for presentation. Each party was allowed to present his/her case and distribute to the Board any additional information relative to the case. After each presentation, the Board went into Executive Session. Following return to Open Session a motion was made to either grant or deny the appeal. A roll call vote was taken. The appellants were advised of the decision of the Board and Mr. Cardwell explained the Due Process Procedure in the event the appeal was denied. It was determined that nine (9) affirmative votes were needed to pass a motion or restore eligibility.

Ms. Claudia Hicks made a motion to grant the appeal. Ms. Cookie Henson seconded the motion which passed by a vote of 9-1.

- 2) Andy Petridis - Scott High School  
Mr. Frank Cardwell made a motion to deny the appeal. Ms. Cookie Henson seconded the motion which passed unanimously.

Mr. Ken Cox arrived at the meeting.

- 3) Travis Hightower - Trinity High School  
Ms. Cookie Henson made a motion to deny the appeal. Mr. Tom Bryant seconded the motion which passed by a vote of 11-2.
- 4) Jenelle Shepherd - Magoffin County High School  
Ms. Claudia Hicks made a motion to grant the appeal. Mr. Frank Welch seconded the motion which passed unanimously.
- 5) Brad Short - Bath County High School  
Mr. Ken Cox made a motion to deny the appeal. Mr. Frank Welch seconded the motion which passed unanimously.

Mr. Claudia Hicks left the meeting. President Cardwell called for a lunch recess at 11:53 a.m.

Mr. Cardwell reconvened the meeting at 1:25 p.m.

- 6) Carri Lyde - South Laurel High School  
Mr. Ken Cox made a motion to grant the appeal. Mr. Tom Bryant seconded the motion which passed by a vote of 9-3.

President Cardwell deferred consideration of the Hall of Fame selections to the May meeting.

There being no further appeals to come before the Board, the meeting was recessed until 9:00 a.m. on Tuesday, April 18.
