1) Determine the number of teams at the varsity, junior varsity, and freshman levels for boys and girls. (\#1, 4, 7)
2) Determine the total number of participants for boys and girls at each competitive level. (\#2, 5, 8)
3) Calculate the percentage of female and male participants at each level. ( $3,6,9$ ) Example: Take the total number of female participants from the Summary Program Chart 1 (Form T-1) and divide it into the number of total participants for each varsity, junior varsity and freshman level. Perform the same calculation for male participants. For example, if there are a total of 300 female participants, and 180 girls are on varsity teams, 80 girls on junior varsity teams, and 40 girls on freshman teams, then $60 \%$ of girls' participation opportunities are at the varsity level ( 180 divided by 300 ), $27 \%$ are at the junior varsity level ( 80 divided by 300 ), and $13 \%$ are at the freshman level ( 40 divided by 300 ).
