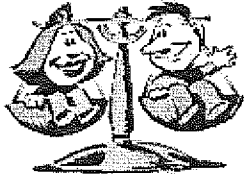

## **Selection of Cheerleaders**

Oneida Baptist has one varsity cheerleading squad that cheers at an equal number of boys and girls basketball games. We do not "cut" at Oneida. Everyone who comes out makes the squad.

## **Prime Time Contests/Girls' Basketball**

Our boys' basketball team has 14 home games scheduled for 2004-2005, and 6 of those games are in prime time.
