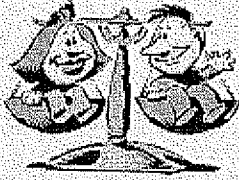

D.	✓	<p>Other Recommendation and Comments:</p> <ul style="list-style-type: none"> ▪ Form T-41 indicates that the boys have an advantage in the area of publicity; however, your Corrective Action Plan (Form T-60) does not indicate how school personnel plans to correct this situation. ▪ Form T-1 indicates that your percentage of total participation is 44.1% for girls and 55% for boys; however, Forms T-35 & T-36 indicate that 63.4% of the athletic budget was spent on boys, while only 36.6% was spent on girls. The Gender Equity Review Committee needs to meet and find a way to bring the budget into better balance. ▪ Please submit a new Form T-60, Corrective Action Plan, to the KHSAA no later than June 15, 2005, which reflects both the issue of publicity and the issue of the athletic budget. ▪ The Gender Equity Review Committee needs to address the following four items and submit an explanation on each of the four to the KHSAA no later than June 15, 2005: <ol style="list-style-type: none"> 1. The \$8,700 difference in boys'/girls' basketball equipment. 2. The \$6,000 difference in baseball/softball equipment. 3. The \$600 difference in baseball/softball awards. 4. The zero amount the six sports are in awards to determine if there is an issue as to why some sports are receiving awards and others are not.

- 1) Determine the total number of girls enrolled, (place in Row 1, Column 1). Determine the total number of boys enrolled, (place in Row 2, Column 1).
- 2) Add the total number of girls and boys enrolled to determine total enrollment, (place in Row 3, Column 1).
- 3) Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. (Divide Row 2, Column 1 by Row 3, Column 1 and place in Row 2, Column 2.) Note: Row 1, Column 2 plus Row 2, Column 2 should total 100%.
- 4) Ask the head coaches to review the most updated eligibility or squad lists for their teams. Ask coaches to confirm the names of those individuals who are on the team as of the first **date of competition**, and cross out the names of those who were cut from the team or quit the team prior to the first competitive event.
