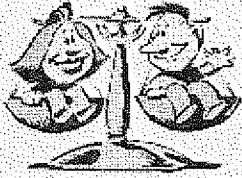

D.	✓	<p>Other Recommendation and Comments:</p> <ul style="list-style-type: none"> ▪ According to the data submitted, the school appears to currently be meeting the standards established in Test # 1 and Test # 3 for Athletic Participation Opportunities. ▪ A major concern is the disproportionate amount of expenditures on boys' athletic teams in relation to girls' teams. According to the expenditure figures submitted, school personnel are spending <u>\$240.83 per male athlete</u> and <u>\$93.41 per female athlete</u>. This spending pattern should be closely monitored by school administrators as well as the Gender Equity Review Committee. ▪ Next year's report should show movement toward parity in this area.


