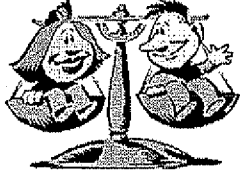

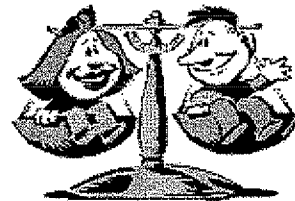
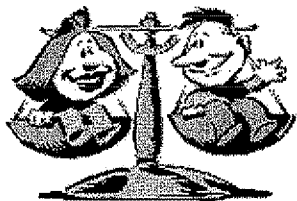

According to data submitted the school is currently meeting the standard established in both test #1 and test #2 for the provision of athletic opportunities. Responses on test #3 also indicate that the standard for this test is being met. It should be noted that the responses on T-3 are not supported by the information in the most recent student athletic survey. The survey indicates an interest in both girls' tennis and volleyball. Spending data on this report does not appear to fall within acceptable parameters. Athletic spending should be monitored closely both by the school administration and the Gender Equity Review Committee. The Gender Review Committee meeting minutes submitted to KHSAA look very appropriate.



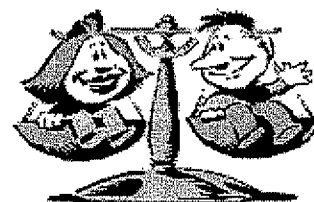
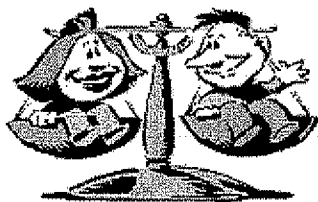

- 1) Determine the total number of girls enrolled, (place in Row 1, Column 1). Determine the total number of boys enrolled, (place in Row 2, Column 1).
- 2) Add the total number of girls and boys enrolled to determine total enrollment, (place in Row 3, Column 1).
- 3) Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. (Divide Row 2, Column 1 by Row 3, Column 1 and place in Row 2, Column 2.) Note: Row 1, Column 2 plus Row 2, Column 2 should total 100%.
- 4) Ask the head coaches to review the most updated eligibility or squad lists for their teams. Ask coaches to confirm the names of those individuals who are on the team as of the first **date of competition**, and cross out the names of those who were cut from the team or quit the team prior to the first competitive event.
