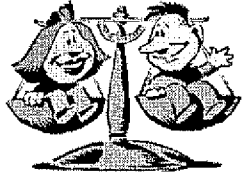

The Gender Equity Committee and school administration should review this spending to ensure equity with all athletes. Presently, it appears the boys have the advantage in Support Services and this advantage should be reflected on form T-41. If it is determined by the committee there is an advantage then the school should devise a plan to correct the spending and reflect the plan of action on the school Corrective Action Plan for implementation.


