According to data submitted, the school is currently meeting the standard established in all three tests for provision of athletic opportunities. In the benefits area, per athlete spending appears to be slightly outside acceptable parameters (approximately \$484 per male athlete as compared to approximately \$375 per female athlete). This spending should be monitored by school officials as well as the Gender Equity Review Committee.
