In the area of opportunities, the school's documentation in regard to pursuing the indicated interest in girls soccer seems to show that Test 3 for provision of athletic opportunities is currently being met. In the area of benefits, total athletic spending is outside acceptable parameters both on a per athlete and percentage basis. This issue is <u>not</u> addressed on the school's most recent Corrective Action Plan (T-60). This <u>spending disparity should be closely monitored</u> by school officials so that it does not continue over a two-year period.</p>

- Determine the total number of girls enrolled, (place in Row 1, Column 1). Determine the total number of boys enrolled, (place in Row 2, Column 1).
- Add the total number of girls and boys enrolled to determine total enrollment, (place in Row 3, Column 1).
- Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by Row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. (Divide Row 2, Column 1 by Row 3, Column 1 and place in Row 2, Column 2.) Note: Row 1, Column 2 plus Row 2, Column 2 should total 100%.
- Ask coaches to confirm the names of those individuals who are on the team as of the first **date of regular season competition**, and cross out the names of those who were cut from the team or quit the team prior to the first regular season competitive event. 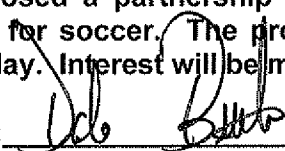

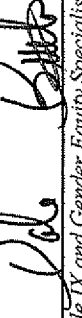

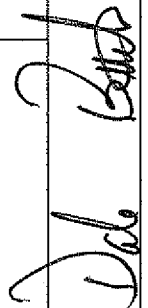
