E.	X	Other Recommendation and Comments: All calculations appear to be correct, and the report is in good order. According to data and responses submitted, it is likely that the school is meeting the standard established in Test 3 for the provision of athletic opportunities. The school offers all sanctioned sports for girls at the varsity level except swimming in which there is not sufficient interest at this time. In the area of benefits, total athletic spending is outside acceptable parameters both on a percentage and per athlete basis (approximately \$487 per male athlete and approximately \$324 per female athlete). This spending should be closely monitored to insure that the disparity does not continue over a two-year period. The supervision of this spending should also be a part of the school's Corrective Action Plan.





School personnel are continuing to make periodic reviews of the boys' and girls' athletics program reflected in the Corrective Action Plan.



- 1) Determine the total number of girls enrolled, (place in Row 1, Column 1).
 Determine the total number of boys enrolled, (place in Row 2, Column 1).
- 2) Add the total number of girls and boys enrolled to determine total enrollment, (place in Row 3, Column 1).
- 3) Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by Row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. (Divide Row 2, Column 1 by Row 3, Column 1 and place in Row 2, Column 2.) Note: Row 1, Column 2 plus Row 2, Column 2 should total 100%.
- 4) Ask coaches to confirm the names of those individuals who are on the team as of the first **date of regular season competition**, and cross out the names of those who were cut from the team or quit the team prior to the first regular season competitive event. Determine the total number of interscholastic athletics participants that are girls, (and place in Row 1, Column 3). In order to determine the total number of athletics participants, an individual should be counted each time he or she participates on a team. 
