The school received a waiver relating to these signatures from Mr. Bilberry (4-30-09). Since the school took steps to pursue the indicated interest in girls soccer, it is likely that the standard established for Test 3 is currently being met. In the area of benefits, total athletic spending seems to be slightly outside acceptable parameters on a per athlete basis. This spending should be closely monitored, and the oversight of this situation should be a part of the school's Corrective Action Plan.</p>




