X	<p>Other Recommendation and Comments: According to calculations, data, and responses submitted, the school is likely meeting the standard established in both Tests 2 and 3 for the provision of athletic opportunities. The school currently offers all sanctioned sports for girls at various levels except swimming which does not seem to be a feasible option at this time. In regard to Test 2, the school has added three teams for girls during the past five years which has increased their participation by 31%. In the area of benefits, total athletic spending is barely within acceptable parameters on a per athlete basis (approximately \$602 per male athlete and approximately \$502 per female athlete). This is a significant improvement over the previous year. School officials should continue to monitor this spending for equity and report the steps taken in relation to this oversight on the Corrective Action Plan.</p>
