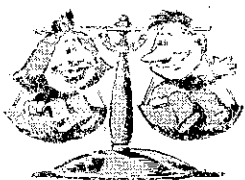

E.		Other Recommendation and Comments: After several phone calls the Riverside Christian Title IX Report for the 2008-2009 School Year was received. A correction had to be made on the T-2 report. The school reported that they had added no new sporting or levels during the last five year yet they showed an increase of 100%. That was changed to 0% since nothing has been added to indicate a percentage increase. The Gender Equity Committee should reflect the same change in the school's Title IX File. Because of the problems with receiving Title IX Reports in a timely manner Riverside Christian will be recommended to have a School Home Visit by the Title IX Audit Team during the 2009-2010 school years. It is recommended that the Gender Equity Committee begin early to have everything in order for this visit.
