The responses on the T-3 form seem to be supported by the information contained in the most recent student athletic survey. In the area of benefits, total athletic spending is very high due to improvements made at several of the school's athletic facilities. This spending does appear to be within acceptable parameters on a percentage basis. (i.e. 40% of the expenditures were for female athletes who made up 42% of the participants.) Thanks for your continued efforts in relation to this project.
