Although there is an indicated interest in girls swimming, there does not appear to be enough schools in the geographic area currently offering the sport for the development of a "reasonable schedule of competitions." In the area of benefits, total athletic spending appears to be within acceptable parameters on a per athlete basis. Thanks for your continued efforts in relation to this project.</p>




