Call to Order of the Full Board of Control Meeting by President Carrell Boyd

Review Schedule for Day including Annual Meeting and Solicit Necessary Additional Information

The Board then Recessed into Work Session with the Following Topic Discussed and no action being taken during the work session.

- **KSBA Question and Answer** Katrina Kinman of the KSBA provided the Board with an opportunity for inquiries and provided information relative to the online board meeting system.
- Lawrence County Baseball Presentation Lawrence County Athletic Director and Baseball Coach Travis Feltner gave a comprehensive presentation on a possible scenario that the Board could consider if it decided to classify baseball for postseason based on enrollment. The Board was appreciative of his research and review and will continue discussion at future meetings.
- **Red Bird Christian School Request 1-Agency:** Red Bird Christian School made a presentation requesting additional time and intervening steps to enter into compliance with KHSAA Bylaw 11 and its desire to continue being considered a boarding school as has been its history since the 1920s.
- **Review Potential Swimming & Diving Realignment for 2015-2016:** Staff presented a framework for the development of an alignment of teams for swimming & diving for the 2015-2016 school year. Based on the Board discussion, there will be a proposal brought back in November to be distributed to the membership for feedback and hopeful adoption for 2015-2016.
- **Comprehensive Status of Middle School Report:** Associate Commissioner Cope provided an in depth update on the regulation pertaining to middle schools.
- Consider Appeal from Harlan County HS, XC/TR Request to Use New Enrollment Numbers to Go Back Into Lower Classification: Due to changes in student population, Harlan County requested to be placed back Class 2A in Track and Cross Country despite the enrollment figures that were present when it was placed in Class 3A for the realignment. The data presented by

the school was reviewed, as well as consideration of the precedent of any decision, and the possible need for additional realignment clarity.

- Review Date of Original April, 2015 meeting (originally April 14): The Board was asked to review dates for the possible movement of the April meeting from its original date due to multiple scheduling conflicts. The staff had heard from members with conflicts on the original date, and there was concern that because of spring break, the meeting could not be held earlier.
- Discussion of School Dues Structure, Inclusion of Tickets to Championships: Several school districts have expressed concern with the purchase of state tournament tickets for football and basketball championships for a variety of reasons. These ticket sales are the principle source of income for the KHSAA budget. With that in mind, and looking toward the future, three different regional AD groups have talked to the Commissioner about changing the dues structure of the KHSAA to include tickets to the boys' and girls' basketball, and football championships. Though there was no urgency to the current discussion, there was a desire to discuss feasibility with the Board. The Commissioner solicited input and ideas to be discussed at the November meeting based on the feedback of the Board members.
- Discussion of Alternative School Student Participation, and Request for Correspondence: Staff provided an update for the Board on an issue related to alternative school participation seeking concurrence with a plan to issue correspondence clarifying the issue. Issues include a) being technically enrolled in other than the A1 school; b) possible athletic manipulation; c) minimum amount of time in the alternative school; d) escaping school and school based rules by placement. During discussion, many of the school administrators and the staff expressed concern about any situation where a nonenrolled student could participate leading to the erosion of the school-based foundation of high school sports.
- **Discussion of Proposed Legislation, Participation by Non-Enrolled Students:** Commissioner Tackett requested the Board provide an official position on the proposed bill as it is written, which deals not only with home schools, but with all nonpublic schools.
- Discussion of Data Gathering, Future Potential Changes in Off-Season, Pre-Season, In-Season, and Post-Season Scheduling in All sports: At the July meeting, the Commissioner reported on his intentions to gather data and review options regarding the manner in which the seasons are constructed in all KHSAA sports. This was to include pre-season, in-season, postseason, summer and the year round calendar. The intention was to involve various constituent groups to gather data and report it back to the Board of Control for review in determining whether or not further bylaw and policy changes are needed. For the last several years, this issue has been handled by patching holes and an overall global look has not been done since the late 1970s when the original limitation of seasons was developed by a group of principals, ADs, coaches and Superintendents. When the issue was mentioned in July, no Board action was requested or needed, however, some members felt the need to revisit the issue to ensure clarity. In discussion, there was concern expressed that perhaps this is solely an item for Board consideration, and that this should be exclusively done by the Board. Other discussion supported the gathering of options, opinions and an assessment of the state of the association, before determining if any Board action was relevant. Many expressed desires to be careful that participation opportunities are not reduced by any future action. There was no action taken on this item and none is immediately contemplated.
- Reconsideration of Ticket Distribution Policy and Review, including Former Board of Control Members: President Boyd requested the Board revisit a change made at the July meeting concerning the policy that grants complimentary admission to the KHSAA boys' and girls' basketball tournaments, and the football playoffs, regardless of the length of time that has expired since service on the Board. The original concern by Board members was the public perception of this benefit after service was completed. Staff's concern was the lack of clarity on usage that allowed some people to get the tickets directly for other individuals and not use them

for the Board of Control member. Additionally, staff's concern involved the football finals and girls' basketball tournaments, where despite several tickets being issued, the vast majority were not used by the actual board members, or were given to otherwise purchasing ticket buyers. Alternatives were discussed with the Board members and staff for the formation of an alternative solution.

In order to be considered for adjustment, the four-year average enrollment (including 2014-15) would have to be within the boundaries of another class, and the school shall have had at least a 10% change in average enrollment during the two-year period.*
