Discuss Football Bracket Rotation per Realignment Discussion (5A, 6A)

Commissioner Tackett provided extensive information on the discussion around the state concerning football playoff bracketing.

With the final adoption of the alignment for 2015-18, the Board deferred consideration of the bracketing question for Class 6A until the 2015-16 school year. For eight years, the pairings in Class 6A have rotated on a planned cross-bracket format to allow for different opponents most years. During the realignment process, several schools in the new regions 5, 6, 7 and 8 expressed opposition to the continuation of the cross-bracket rotation. Member schools in 1, 2, 3 and 4 expressed support for continuation. When pressed at local meetings, the primary reason appears to be competition based. However, elimination of the rotation does ensure that the bracketing in all classes is done in the same manner.

The Board has the authority to bracket the classes differently from each other, as well as the authority to make all classes the same. It should be noted that even within the limitation of seasons, the schools have clearly acknowledged the fact that all classes may not always be configured the same.

A survey of the schools in 6A would likely yield divided results, but remains an option. The Board needs to determine during the 2015-16 school year, the method of pairings for 2016 through 2018 playing seasons.

During the realignment process last year, representatives in Class 5A also made a request for rotation for a variety of reasons.

The currently constituted Board with the knowledge of the school request during alignment, but also the knowledge of the reasons for the rotation in the first place, needs to help guide the next course of action on this matter.

Discuss Possible Changes in Baseball Tournament Format

The Commissioner and Associate Commissioner concur that a review of the state baseball tournament, since the change in format to a 16 team event, is in order. With the likely adoption of a pitching rule in the next year or two, at the national level, and the current format of four games in six days; few high school teams are going to be equipped, personnel-wise, with a more restrictive pitching rule. While the move to 16 teams has been the promotional element for baseball that was envisioned, it has also served to further divide the membership, which was very accurately described by Coach Feltner of Lawrence County in his classification presentation.

As there are several alternatives, classification may not be the answer to the problem. The Commissioner pointed out that adding to travel costs for a championship as well as expanding the time needed for baseball, at a time when there are significant issues with scheduling, could create even more of an issue.

The Board directed staff to work with the Lexington Legends and bring back scheduling options for revamping the state tournament to be held over two weekends. This would truly balance the large and small schools in terms of pitching to ensure that no more than two games are played each weekend. That could be detrimental to attendance and with the unique partnership with the Lexington Legends and an existing agreement through 2018, their involvement is needed in discussion.
