#### Finance/Administration

#### **Consideration of Fee Changes for Postseason Officials Elimination of Mileage**

Through research for the annual review of fees, staff determined that most states, particularly in early playoff rounds, no longer paid mileage and have adopted flat rate fees. This is similar to the

small and mid-college level where bookkeeping issues led to standardization. Additionally, it shifts the onus to the assigners to ensure that the same officials aren't repeatedly traveling great distances and allows for geographically neutral assigning. Staff felt that the data gathered in this effort allowed for a complete revisit into postseason fees and adoption of fees that would be expense neutral to the membership but greatly benefit all involved in game administration.

# Consideration of Allowance for Two-Person Soccer Crews and Change in Regular Season Fee

Staff had reviewed and studied the fees and fee costs associated with soccer regular and post season. In keeping with the fee research and the realization that the fee in soccer is outmoded and outdated, and likely contributing to the problem of shortage, data was presented.

**Motion Passed:** That soccer be permitted, at the request of the schools and collaboration with the assigner, to use a two-person system in regular season games and that the fee structure for soccer be revised to a state minimum of \$50 per game for three officials (no permitted reduction in current local policy board travel allowance) and \$75 per game for two officials passed with a motion by Debbie Beichler and a second by Henry Webb. #### **Consideration of Soccer Fee Changes - Postseason**

The results of a study by Staff was given concerning the fees and fee costs associated with the soccer regular season and playoffs. In keeping with the fee research and the desire to adopt a flat, no mileage fee structure, data was presented.

#### Request for Pilot Project, Regional Format, 15th Region

Due to the upcoming consolidation of South Floyd and Allen Central High Schools, changes are needed in the alignments for basketball, baseball, softball, and volleyball in the 15<sup>th</sup> Region.

The Superintendents in the impacted districts met January 9<sup>th</sup> to review options related to the region. The district is not perfectly geographically aligned and the Superintendents considered at least five options for the placement of teams. The resultant discussion continued a pattern of discussion wherein the schools in this region, much like Region 1, are facing a loss of teams and very few obvious non-impactful answers to future alignment needs.

Rather than shifting teams around from different regions, the Superintendents prefer a potential three-year pilot where their teams can play one less regular season game, and play a modified regional tournament with an extra round, with all teams advancing to the region tournament but seeded by regular season play/rankings, etc. This pilot could provide great data for other regions who may face a similar issue in the future with further school consolidations. A list of alternatives was available.
