Adoption of Officials Fees for 2018-2019 Per Schedule, Volleyball, Cross Country, Track and Swimming

Annually, the Board of Control reviews the officiating fees in selected sports for possible revision, with any incremental change being in postseason fees.

Last year, the Board of Control approved an overhaul in all sports which resulted in slightly higher game fees for all sports and the elimination of mileage.

The Board had previously adopted a sport rotation wherein all sports are reviewed every four years for possible revision. It is in the year following those reviews that regional policy boards are to review non-varsity and travel fees in those sports.

For 2018-2019, the recommendation was:

- 1. No change in the basic fees in any sport, and specifically no change in Volleyball, Cross Country, Track and Swimming;
- 2. A standard fee for the line judges in volleyball to be 50% of the officiating game fee for all postseason levels, local determination for these positions during the regular season;
- 3. Volleyball to be re-evaluated during 2019-2020 and every four years thereafter for additional changes.

Formal Approval of Employee Handbook Revisions

At the November meeting, the Executive and Audit Committee was briefed on the situation with the KHSAA support staff due to the pension situation. Position revisions were made by the Commissioner and approved by the Board of Control provided those changes remained in compliance with the adopted budget. Further review by KHSAA Counsel, outside Counsel and the Commissioner was directed to see if any additional changes were necessary.

Following that review, additional changes were requested to be made to the employee handbook and required formal approval by the Board.

- 1. No new employees will be placed in the position of Administrative Support Specialist or Receptionist/Clerical;
- 2. Regular, part-time positions, not to exceed 25 hours per week/100 hours per month were approved for Administrative Events Coordinator 1 and 2 as well as Senior Administrative Events Coordinator, which will be hourly positions;
- 3. The Director positions will be re-titled to Director 4, 3, 2 and 1, with Director 4, 3 and 2 requiring a college degree and no additional Director 1 positions allowed to be hired;
- 4. That the position of Executive Assistant/Office Manager is created and shall, in the future, only be available to someone with a college degree;
- 5. That the threshold for Health Insurance Coverage as provided by the Association be set at 25 hours per week/100 hours per month.

Approve Closure of Forcht Bank Account and Transfer to General Fund, Adjusting Entry to Close Museum Restricted Funds and to Close Unawarded Sponsor Scholarships into Stout Account

When the museum area was built in the early 2000s, a separate bank account was established to house money raised during fund-raisers, etc. to keep those funds in a different account. When that project was completed, all restricted dollars had been expended.

As part of housekeeping entries following the 2015-2016 audit of the KHSAA, it is essential that some of these old funds be cleaned up so that there are no misgivings about the position of the Association. The following transactions were recommended:

- 1. The account at Forcht Bank (approximately 14,000) be closed and moved to the General Fund account,
- 2. That adjusting entries be authorized to remove any restricted museum amounts from the General Fund.
- 3. That adjusting entries be made to close the funds currently listed as reserved for Sportsmanship Scholarships to be moved to the accrued, unawarded for the Stout Scholarships,
- 4. That the requisite entries and cash transfers be made to balance the sick leave designated fund for the association

Revisions in State Archery Format

Following extensive review, staff recommended restructuring of the Region and State Archery competition. These changes had been reviewed with the Archery Advisory Committee at its meeting on January 9, and are presented for approval so that staff may proceed with development of final information to be given to the Board of Control in February and implemented for 2018 competitions.

Primary changes would be:

- 1. Develop and conduct a separate division of competition for teams composed of females only,
- 2. Allow schools without enough to have a full team of females to permit those females to participate on the boys' teams for the school,
- 3. Authorize a budget amendment to allow for the top four teams to be recognized with trophies in the female division.
- 4. Report full implementation plan to the Board at its February meeting.

Discussion on Penalties and Subsequent Suspension from Contests

Final Adoption of Revisions to Region 11 (and possibly 8)

In November, four options were discussed for the 11th region (and potentially the 8th region) to be realigned due to the opening of Great Crossing High School. The Board tentatively approved Option 3 as listed below, and such was distributed to the membership for feedback. There was minimal feedback but there was a proposal to totally revise the statewide regional alignment in all regions.

Following the feedback from the membership, and with the documentation that Frankfort Christian is in fact scheduled to have basketball beginning in 2019-2020, the topic merits review. Of these four options, it appears that Option 2 rather than Option 3 may in fact be the best course of action for the Board of Control. Though it does not meet the wishes of the Scott County Schools original request, it is apparent that there will be at least some dissatisfaction with any recommended change.

RECAP OF NOVEMBER OPTIONS

With the opening of Great Crossing High School, the 42nd and 43rd districts will be composed of more teams than desirable within the Board's parameters. The Board stated preference in the past is to have districts with no less than four (barring geographical impossibilities) nor more than five teams. The Superintendent of the Scott County schools had requested that if possible, the two schools be placed in the same district.

Adding Great Crossing to District 42 would mean a total of six teams in that district, with five in the adjacent 43rd district. Woodford County is adjacent to District 30, and would give that district a total of five teams. District 31 also has five teams.

Four options were discussed in November-

OPTION 1

Add Great Crossing to District 41. Scott County borders Franklin County and the two are easily connected. In this manner, the only impacted schools are those in District 41 and the new school, leaving 41 with five teams.

OPTION 2

Move Woodford County to District 30 (Woodford is adjacent to Anderson). Then add Great Crossing to replace Woodford County in District 41.

OPTION 3

Move Woodford County to District 30 (Woodford is adjacent to Anderson). Then add Great Crossing and Scott County to replace Woodford County in District 41. District 41 would now have 5 teams along with District 43, while 42 and 44 would have four each.

OPTION 4

Add Great Crossing to District 42 with Scott County, and move Sayre to District 44. This move would not be geographic in nature but would balance the numbers of teams.

Motion Passed: Based on the feedback from the schools and based on new information relative to Frankfort Christian Academy, adopt Option 2 as the realignment for basketball (and the other team sports based on basketball) for the 2019-2020 school year passed with a motion by Jeff Saylor and a second by Bonnie Barnes. Football Playoffs, 2019 and Beyond

Additional options and discussion were held as the Board works toward the alignment of teams for 2019 and beyond as well as a review of discussions held within the Football Advisory Committee on January 9, 2018.

Primary requested change was a rebracketing that would start in 2019 by seeding the fourth round of the playoffs. No method was recommended by the committee, but the thoughts of promoting football at a key time before the finals and enhancing the quality of the matchups beyond the regional were paramount. It was noted that the semifinals are in effect the first round of the state when compared to all other championships. It was also noted that the plan should include alternation of sites for repeat matchups as is the case with the current 3rd and 4th round for identical seeds.

Motion Passed: Give tentative approval to the recommendation for fourth-round seeding of the playoff brackets and direct staff to bring back implementation plans and options for seeding methods prior to final approval at the May meeting passed with a motion by Debbie Beichler and a second by Bonnie Barnes. This was viewed as essential as it could impact scheduling decisions following the adoption of the alignment. It was also strongly suggested that for clarity, the region numbers be the same in all five classes.

Tentative Division of Classes, Football 2019-22, Playing Up Discussion

Since January, 2014, schools have had the option to voluntarily play into a higher class with the only restriction being that they shall remain in the class for the entire four-year alignment and such request be made prior to an established deadline before district boundaries are established. If a team does elect to play up, the lowest enrollment average school in the higher class should be given an option to go to the lower class. That procedure would be repeated a maximum of three times

Using the current four year enrollment average combination direct staff to begin the communication process for schools "playing up". The Board also requested Staff poll the schools in Class 1A about playoff bracketing.

Motion Passed: Allow the schools to voluntarily play into a higher class subject to the approval of the Board of Control with the only restriction being that they shall remain in the class for the entire four year alignment and such request be made prior to an established deadline before district boundaries are established. If a team does elect to play up, the lowest enrollment average school in the higher class should be given an option to go to the lower class. That procedure would be repeated a maximum of three times with lowest enrolled schools passed with a motion by Jeff Saylor and a second by Scott Hawkins. Volleyball Season 2018-2019

With the recommendation from the Volleyball Rules Committee and Staff, the Board approved a change to the 2018 volleyball season due to scheduling issues with the State Tournament and hotel availability. Louisville will be hosting the Breeder's Cup during the weekend when the state tournament is normally conducted according to the corresponding date calendar.

The original staff request, which was approved by the Board of Control, would begin the postseason (District, Region and State) one week earlier, leaving all other corresponding dates as published, effectively shortening the regular season by one week.

Recently, when scheduling conflicts with the state basketball tournament venue were shared for 2021, the Board approved shifting both the beginning of the season (first contest date, postseason,

etc.) and the beginning of the postseason one week earlier, therefore not affecting the length of the season.

Based upon the action taken to address the basketball scheduling conflict, staff requested the Board adjust the season comparable to basketball with regard to volleyball and allow those schools to hold contests during NFHS week 6 (August 5 through August 11) for the 2018 playing season. Effectively with this change, the volleyball options for scheduling for 2018 only would be:

- 1. First Organized Practice July 15
- 2. First Official Contest Monday, August 6 (NFHS week #6)
- 3. District Tournaments Oct. 8-13 (NFHS week #15)
- 4. Region Tournaments Oct. 15-20 (NFHS week #16)
- 5. State Tournament Oct. 26-28 (NFHS week #17)
- 6. For 2019 and beyond, the start of the season would return to NFHS week 7
