Constitution and Bylaws Issues

Implementation of Changes Made at Fall, 2018 Annual Meeting

There were four changes passed by the Delegates at the September, 2018 Annual Meeting of the membership. Three of those changes impact the transfer rule and its application.

The proposals are: 1) clarify that transfer ineligibility impacts only those sports in which the student has participated in the last 365 days prior to enrollment; 2) allow for practice or non-varsity competition at the discretion of the member school while a ruling is in progress and 3) add a specific exception for situations applicable to KRS 158.148 (Bullying). These rules are currently working their way through the promulgation process and will likely see final effect around July 15, 2019.

The Commissioner is requesting approval of an interpretation that will state that for transfers submitted on or after May 13, 2019, staff will utilize these provisions in making student eligibility rulings. Without this interpretation, many rulings made between now and the final effective date would have to be re-adjudicated in order to have a non-disparate impact on students enrolling for 2019-20.

Enrollment Verification Interpretation

To ensure consistent application of all KHSAA Bylaws by the membership for Bylaws 4, 6, 23 and 24 clarity was needed. The Commissioner and Staff proposed interpretations to assist with what to do with new students, in terms of enrollment, who participate over the summer before "sitting for class" as defined by KDE.

The proposed interpretation states a school's summer open facility program is only open to:

- 1. Students who attend the school,
- 2. To students who attend a feeder school of the school as defined by the local Board of Education adopted policy,
- 3. To incoming 9th grade students who are no longer enrolled at the non-feeder school and have enrolled at the member school,
- 4. Newly enrolling students in grades ten, eleven or twelve that are not subject to the provisions of Bylaw 6, 7 or 8; and
- 5. To transfer students subject to Bylaw 6, 7 or 8 who have enrolled at the school and who have completed and submitted to the KHSAA an KHSAA Transfer Form (if one is required by the Bylaw 6, 7 or 8 situation).

"Any adult spectator (adult who is not listed on the current roster of coaches for the school) at any KHSAA sanctioned interscholastic event (scrimmage, regular or postseason contest) who is removed by school administrators or by law enforcement (whether or not referred by an official) shall be suspended from attending, at minimum, the next contest at that level of competition and all other contests at any level in the interim."

This award was the highest scoring school that entered both boys and girls swimmers and was an effort to ensure additional recognition.

The awards have expanded to a situation where the combined trophy is now given to the first and second highest point totals, by presumably the coaches association when in fact; the Association has funded these coaches association awards.

The swimming and diving coaches association is nearly non-existent and the issue is the continuance of these awards. Staff recognizes that unique to swimming, the long-standing participation history by specific single-gender schools will likely not decline any time soon, and this recognition is vital to the continued growth of this sport.
