Discussion of realignment process for football and track in light of current enrollment situations- The Commissioner had a general discussion on the realignment process in football and track and field. With no new binding enrollment numbers for 2021-22, the normal protocol cannot be followed. While attendance numbers are an option, it is possible that this will severely skew the comparative review of school sizes. The use of enrollment, due to its linkage with funding, has always been viewed as more reliable.

Initial Discussion, Membership Options for A5 schools- The Commissioner reviewed the situation with W.E.B. DuBois Academy, and requested additional board feedback on expanding membership to A5 schools.

Consider Deadline for Physical Exams- Board members requested details on revising the due date or validity date of physical exams within the member schools.

Status of Regulations- Staff reviewed the status of current rules promulgation as well as reviewed the difficult timeline of future rules changes.

Member School Operations and Non-Sports Specific Event Issues- The Commissioner and staff reported on action thus far that was part of the July meeting on membership as a follow-up.
