#### Meade County Football Request to Appeal Alignment and Utilize 5/3 Plan

## Follow-up Items, Basketball Region 15

## Basketball Request for Pilot Region Tournament - Region 15

In 2017, the Board approved an experimental regional tournament format for the 15th region as they had fallen to less than 16 teams. There are now fourteen teams in the region, divided into two four-team districts and two three-team districts. That experiment didn't work out as negotiations broke down over scheduling the required number of games and was never utilized.

With the movement of Jenkins High School back to Region 14, there are again fourteen basketball teams in the region. Following a series of meetings, the schools in Region 15 voted 9-6 in favor of a revised format, with the schools in the 57th and 58th districts voting yes, and the schools in the 59th and 60th districts voting no.

There is no procedural requirement for a specific vote. The Board in the past has felt that other than the site selection plan, there is no required vote as it was viewed that these decisions impacted only the teams in that region.

Representatives explained the plan. If the plan does not get approved, the 4-4-3-3 plan remains in place.

## **Legislative Report and Status of Regulations**

Staff gave a review of the current legislative session, including up to the moment updates. In addition, HB396 was introduced Tuesday, 2/21 and HB331 was amended by the author during the week. The Commissioner informed the board that it is not likely wise to eliminate the Prime Date requirement for a variety of reasons. but could look to amend it.

If HB331 does pass CPR of is negotiating to work a deal with the schools to help with cost of the AEDs. That information has not been released and will only be released when the bill passes. It was also that staff is monitoring all gambling bills and the impact that would have on interscholastic athletics.

## **Sports Reports from Staff**

Written reports were submitted by the Commissioner's office specific to recently completed or upcoming championships. The Commissioner and Assistant Commissioner Bridenbaugh reported on the capacity issue at swimming and will bring an alternative plan to the May meeting. They also reported on the proposed rule change for transgender athletes to wear suits that come above the waist.

#### Staff Reports - Not Sports or Sport-Activities Related

The Commissioner and Assistant Commissioner reported on NFHS rule committee meetings attended. Commissioner Tackett and Associate Commissioner Cope attend the football rules committee, Mr. Collins attended the soccer rules committee and Mr. Cope attended the spirt rules committee.

## **RPI Out of State Factor and Comparative Data**

Just for information of the Board, this report showed the record of Kentucky teams against teams from out of state as this will be topic for upcoming discussion. In addition, there was information about an alternative format that may become a source of discussion in the future, both positive and negative, referring to the winning percentage for play out of state teams and using specific sports.

## Officials Licensing Comparison and Arbiter Sports Update

The Commissioner and Associate Commissioner spoke on the lack of officials and how that is forcing inexperienced officials in to positions that they may not be ready to officiate. Mr. Cope also reported that the KHSAA is looking to work with Refreps to help educate officials to help better prepare them.

#### Status Report - Bowling Green High School

As part of its June 23, 2022 agreed order in a past matter, there is to be a status report at each Board meeting. The deadline for the school to get organized was August 1, 2022 and staff has been assigned to serve as liaison with the school so this work can begin regarding the monitoring. Assistant Commissioner Angolia reported that all but nine coaches have attended the coaches training. He is working with Bowling Green on how they can get those coaches in compliance.

## Status of Bylaw 11 Financial Aid Reports

Assistant Commissioner Bridenbaugh reported that she is in communication with the schools that are not yet in compliance and will continue to follow-up.

Staff discussed strategic goals around which the plan is being formulated. Strategic Review of Priorities-Strategic Plan including Board Goals, National Priorities, Student Mental, Emotion and Physical Wellness - Value of Participation, Diversity, Equity and Inclusion, Sportsmanship, Ethics and Integrity, Case for Education-Based Athletics, Officiating - Recruitment and Retention.

#### Additional State Priorities

Next Steps are Championship review in light of changing enrollment patterns, Consideration of other factors for the classified sports, and transfer Hall of Fame options to the Foundation.

## **Issues Surrounding Football Alignment**

#### **Discussion of Enrollment and Classification Period**

The plans are to use the 2022-23 enrollment and the 2023-24 enrollment of students to guide the placement of teams into classes for the next cycle in football. The Board should also review if there are any other desired factors to be considered. A copy of the socioeconomic numbers has attached and staff detailed anything going on in other states. The Board could also begin the discussion of any other factor, including past success, that might be analyzed.

#### Consider Playing Up Regulations and Recommendations and Alternatives

As part of the football alignment process, there has been much discussion about "playing up" and its potential impact on placement of teams. Several members have asked for a general discussion about the topic.

In addition, the concept of using a success factor for Class 1A to 5A in football has been discussed over the year as a means of addressing equity. The concepts would be discussed to gather board sentiment and factors to be considered, and then staff could bring back proposed policy language including any potential exceptions (if any) to the May Board meeting. There was no sentiment to adopt at this time.

## Historical Review and Policy Discussion and Current Year Update, Prime Date Scheduling

The Commissioner reported clarity on the Prime Date regulation as it is the date and not the time in which the girls' game is played. Consideration of counting a boys' and girls' doubleheader on any day of the week could then count towards the prime date number. A means of adding options for increased girls emphasis. Staff will come to the May meeting with the numbers if this was implemented this year how many schools would then be in compliance.

#### First-Round State Event Criteria and Desired Execution

Staff desired additional feedback from the Board regarding the issues reviewed around the First Round Golf State (which could eventually impact First Round Swimming State). Ideas are experience, presentation, etc. Staff has begun this review which was committed to be done for the May meeting but desires additional input.

With feedback from the Board the staff will look to have more signage and banners to give more of a state atmosphere, as well as standard announcements and promotions.

#### Approval of Evaluation of Staffing Levels

As needed, the Commissioner reviewed impending plans for personnel, including consideration of full and part-time staffing. Present plans would be to retain a part-time individual to serve as the Supervisor of Officials Licensing, and a second person (full-time) to be in a position entitled Event Services Manager.

This combination would enable appropriate separation of duties as well as allow for expanded event services with the pending changes in additional offerings. The Event Services position could start at the beginning of the fiscal year, with an earlier start for the Officials Supervisor if practical and feasible.

## **Discussion of Possible Annual Meeting Proposals**

The Commissioner and Staff reviewed needed changes as well as membership feedback on possible proposal changes to the Association bylaws. The Commissioner did remind the Board that May 1<sup>st</sup> is the deadline to submit proposals.

#### Items for Discussion and Possible Action

#### Officer Elections - President Elect

The Board of Control annually elects from its membership, a President-elect to serve the following year, and then transition to the President position in the second year following.

Board members here reminded that the officers for the following year are elected at the 5th meeting of the year.

As adopted, the procedure for the election is as follows:

#### A. ELIGIBILITY AND NOMINATIONS

To be eligible to seek the position of President-elect, the individual shall be in at least the second year (rising to the third year) of his/her first term, or in his/her second term. Nominations shall be made in open session with a motion from a sitting member of the

Board of Control. No second shall be required for the nomination.

#### **B. BALLOTING**

Balloting shall be done in open session with a public vote.

#### 1. ELECTIONS WITH ONE CANDIDATE

In an election with one candidate, the candidate shall receive at least ten (10) votes to be elected or may be elected by approval of a properly made motion to accept the candidate by acclamation.

#### 2. ELECTIONS WITH TWO CANDIDATES

In an election with two candidates, a candidate shall receive at least ten (10) votes to be elected.

A ballot that is tied or in which no candidate receives ten (10) votes shall be repeated a maximum of two times.

If three ballots are held with no member receiving ten (10) votes, the election shall be decided by a coin toss with the candidate alphabetically listed first having "heads" on the coin.

#### 3. ELECTIONS WITH MORE THAN TWO CANDIDATES

In an election with more than two candidates, a candidate shall receive at least ten (10) votes to be elected.

If no candidate receives ten (10) votes and one candidate has a greater number of votes than the other two (2) candidates, and the other candidates not having the greater number

of votes are tied, a candidate shall be eliminated by coin toss with the candidate alphabetically listed first having "heads" on the coin. The election shall then proceed according to either section (2) or (3) above based on the number of remaining candidates.

If no candidates receive ten (10) votes and one candidate has a greater number of votes than the other two (2) candidates, and the other candidates not having the greater number of votes are not tied, the candidate shall be eliminated with the fewest votes. The election shall then proceed according to either section (2) or (3) above based on the number of remaining candidates.

## Triennial Survey Report, Consideration of Additional Sports and Sport-Activities for 2023-24 and 2024-25 and Follow Up Action

Staff reviewed the totals from the Triennial Survey Conducted during 2021-22 with current status of implementation and recommendations. Acknowledged Desires of membership and administrative preference for more organized statewide management, but do not manage a championship during 2023-24. Further consideration based on these results during 2023-2024. Implemented and integrated with the existing championship. Based on entries, we will be able to have qualifiers and participants this season.

In conjunction with facility discussions, the desire would be to bring this event as a full championship event in 2023-2024.

Implementation could involve two or four state-qualifying meets, and combinations of existing wrestling regions.

If facility agreements can be reached, it could be held on the same weekend at the same venue. This would necessitate a three-day tournament and avoid any perception of a degraded event for females compared to males.

Current plans would be to have a one-day girls and two-day boys' event and alternate which one is first each year. A survey was supported of the designated representative in conjunction with other items considered in the February agenda.

Per KHSAA Bylaws, adopting a championship would necessitate compliance with NFHS rules on weight management, including the weight capacities in the highest weight class. KHSAA is investigating other opportunities within the rules to see if eliminating some current competitors can be avoided.

The growth in boys' volleyball is exponential and will continue. If played in the spring, the sport could grow, but there is concern that when the survey was taken, schools may not have factored in the impact on the other male spring sports. Staff suggests the development of a prototype limit of seasons, and additional follow-up surveys of the administrators' late summer/early fall of 2023 for further guidance.

Additionally, targeted discussion with both board and staff members of existing leagues and teams should be held to help with feasibility.

shared regarding the sport, tournament size, and issues in various venues where the tournament has been held.

Step one would be a survey to the school administration, on the option of a reduction to two qualifiers from each region and a state event that is one day boys and one day girls at the same site; a consolidated state format wherein boys wrestling would be on Thursday and Friday of one year, girls on Saturday of that year, at the same site and the reverse in the next year; or further sub-division of the intermediate round between region and state to pair two regions for that round, with alternating pairings within each four regions.

The choice would be one and only one of the choices per school.
