Minutes of the Annual Meeting of the Kentucky High School Athletic Association held at the Brown Hotel on April 10th, 1935.

President O'Donnell called the meeting to order at 5 P.M. in the Crystal Ball Room.

The minutes of the last meeting were approved.

Of last years 540 members 25 were dropped on October 1st for non-

Of last year's 540 members 85 were dropped on October 1st for nonpayment of dues; of the 85, 70 were reinstated and 15 were not; 25 former members which had been out of the association one or more years were reinstated; 21 new members were admitted, giving us a total this year of 571 members. Two members were suspended for violation of the rules. 115 schools turned in season football lists. 544 schools entered the district tournaments.
