She won the first of three state HS championships in the eighth grade with a win over Jackie Trail in 1993 for LCA. Her other two titles came in 1996 and '97 for Russell. Then she played for two years with the US National Junior Team in Europe and South America.

Ditty had a very successful college career, winning 114 matches and was a 3-time All-American. After college, she played professionally.

Ditty is the all-time leader in career USTA Pro Circuit titles with 36. In 2008, she competed in the singles main draw of the Australian Open, French Open and Wimbledon, as well as the doubles main draw of the US Open, where she reached the round of 16 with Carly Guillekson. Ditty broke into the Top 100 in singles in November 2007.
