I began my student athlete career a Scott County High School in Georgetown, KY. Although athletic teams were limited during those years, I was able to take advantage of competing on the Track team. My events included the High Jump, the 100, 220 dashes and anchor leg of the 880 relay. Running against the likes of Jim Green didn't give me many opportunities to win but it left me with many great memories. As I moved on to attend Morehead State University, I was asked to be on the track but my work ship did not permit the time to train or compete on that level.

I started my coaching career as an assistant a Butler High School in Louisville under my wife Rita Holman for two years in 1972. During the 73-74 school years I was hired as a teacher and coach at Eastern High School. My coaching duties included boys/girls basketball and the boys/girls track and cross country.
