It is with great pleasure that I nominate Mr. Paul B. Stevens for admission to Dawahares KHSAA Hall of Fame.

Mr. Stevens retired from the Dawson Springs Independent School system in 1975 after 31 years as teacher, coach, principal and acting superintendent. He served under four superintendents. He attended Western Kentucky Teacher's College (Western Kentucky University) on a football work-scholarship and was selected to the Kentucky Intercollegiate Athletic Conference all-state team and the Southern Intercollegiate Athletic Association all-star team.

After graduation, Stevens came back to his Dawson Springs roots, began teaching and coached the school's athletic teams. When World War II began Paul Stevens went to Memphis, Tennessee, where he was a supervisor at a war plant. Upon returning to Dawson Springs he took over coaching the basketball team in 1945, known to many as the "46 Team." They turned out to be the most successful team in the history of the Dawson Springs School System.

Stevens led the squad to a 24-1 regular season record (they were 2-3 in invitational tournaments). From there they captured the district and regional tournament championships and became the *first and only* Dawson Springs team to win a state tournament game. But they didn't stop there as Stevens' Panthers advanced all the way to the finals of the Kentucky High School Basketball Tournament in Louisville and, although defeated by Breckinridge Training in the finals, wrote their name on the record books of Kentucky high school basketball. (The Panthers attended the state basketball tournament three years in a row under coach Stevens.)

The following year Stevens led his team to the state tournament, but was defeated in the first round game. After the 1948-49 season Stevens ended his coaching career at Dawson Springs. During the two seasons in which he was the only coach, Stevens' teams compiled a 52-12 regular season record and a 14-2 post-season record.

Paul Stevens, reflecting on this period in his career said, "My biggest thrill was probably the state tournament in '46."

I am proud to submit his name in nomination for this award.

Dear Sir or Madam:

I take a great deal of pleasure writing this letter of recommendation urging the induction of Paul B. Stevens into the Kentucky High School Athletic Hall of Fame. At age 92, the honor is well past due.

Paul, or Mr. Stevens as I called him when he coached my high school baseball team my senior year, would be worthy of the recognition for no other reason than being coach of the Dawson Springs High School Panther basketball team for four seasons in the mid-to-late-1940s. It truly was our glory years.

The highlight, of course, was a runner-up finish to Breckinridge Training in the 1946 State Tournament. The Panthers finished 36-3 in Paul's first season as head coach. Although that was four years before I was born, through stories in *The Progress* and from "old-timers," it's apparent that except for having to face an exceptional high school basketball team in that championship game, Paul and his Panthers would have captured the coveted title.

He and his players followed that with 32-9, 24-17 and 27-17 seasons before he left the basketball coaching ranks. But he didn't leave sports, or, more importantly, high school sports in Kentucky.

Paul and his long-time friend and fellow Panther football player from the early 1930s, D. Fletcher Holeman, spent many fall and winter days and nights officiating high school football and basketball games in the commonwealth. Again, I can't speak from personal knowledge, but from talking with a number of people, Paul and Fletcher were among the best officials in both sports.

And Paul, Fletcher and another friend at Dawson Springs High School played football at Western Kentucky State Teacher's College (now, of course, WKU). I remember being told that at one time three of the members of the Western line were from the small town of Dawson Springs.

Back to his coaching. A story which I never get tired of telling is that during a basketball game which the Panthers were expected to win, they got behind and the players got worried. At that time, players weren't permitted to huddle with their coach during time-outs. So, one of the players, when close to Mr. Stevens on the bench, yelled, "Coach, what are we supposed to do?" Paul said simply, "You got yourselves in this mess, get yourselves out."


That simple breakdown of basketball strategy—especially now that coaches seem to overcoach what is a relatively simple game—should be included in every book on coaching.

And one more story, this from his officiating days. He and his friend Fletcher (who will match Paul's 92 next month) were officiating a basketball game (I believe it was at Frances—or Francis—where Paul's wife is from.) and Fletcher made a call against the home team which got the crowd riled up, despite being far ahead. It was a small, cramped gym which was full. A friend of Paul's yelled, "Hey Steve (which many of his friends from long ago call him), what's wrong with Holeman?"

In his dry style, Paul replied, "Looks like he's trying to steal the game."

And one last thing, which isn't likely to be a reason for inclusion in a hall of fame, involves Mr. Stevens' stint as baseball coach my senior season (1968). I forget the record; we were usually competitive, but not among the best teams in the area. But I'll long remember that Mr. Stevens came out of coaching retirement to ensure that we would have a baseball season after the former coach left for another school system. He didn't have to do that. I'm sure he didn't relish spending the after-school time at practices and then at the games, especially the away games. But he did, if you will, the right thing. I hope you will do the right thing.
