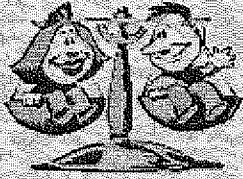

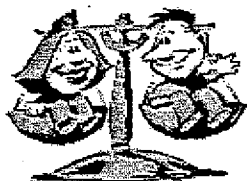

With only 155 students in High School only a "few" students throw off the numbers.
