

NEW SOFTBALL FIELD

We have had to make several adjustments on the construction of a new softball field. Originally we were going to build it at our Elementary School site, but after construction plans were drawn up, this land was purchased by the Department of Transportation to make highway improvements on KY Route #28.

The other plan was to work with the local Booneville Methodist Church who had recently purchased land adjacent to the high school property, and the baseball field. The local bank was to help with constructing the field, lights, and scoreboards, and the church was going to permit us to use it. As of this date the church has put this plan on hold.

We have now decided to build the softball field next to the high school property and the golf driving range. This option was looked at earlier but not used due to a small portion of the field would be susceptible to flooding from the South Fork of the Kentucky River. However, the local bank (Farmers state Bank) has agreed once again to help us build the field and after consideration and checking with some other school systems who's fields are also flood prone, we have decided to contract a person to begin surveying and doing the bull dozer work to begin the field. We feel the flooding would have no negative effect on the new field.
