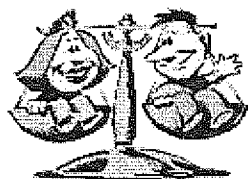

It is recommended that students be placed on the Gender Equity Review Committee, and that they be active members of the Committee. It is recommended that your Gender Equity Review Committee meet at least once during the fall sports season, once during the winter sports season and once during the spring sports season. With regard to the Student Interest Survey, you need to survey 9th graders also. Your survey shows interest for a girls' tennis team; this should be pursued and reflected on Form T-3. If indeed this interest is significant, the school is currently not meeting the standards established in any of the three opportunities tests.

Using the same procedure, determine the total number of interscholastic athletic participants that are boys, (and place in Row 2, Column 3).
