



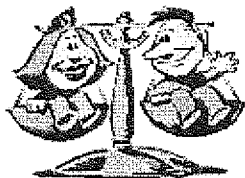

D.	✓	Other Recommendation and Comments: ▪ With one minor correction, your report appears to be well done. ▪ It appears from the data submitted that the school is currently meeting the standards established in Test #1 and Test #2 for athletic Opportunities. ▪ The one area of concern is the data submitted on Forms T-35 & T-36 indicate that you are currently spending \$143 more per male athlete than per female athlete. This would lead to the conclusion that benefits may well be an advantage for the male athletes at your school. This situation should be checked and closely monitored both by your school administration as well as the Gender Equity Review Committee.

- Add the total number of girls and boys enrolled to determine total enrollment, (place in Row 3, Column 1).
- Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. (Divide Row 2, Column 1 by Row 3, Column 1 and place in Row 2, Column 2.) Note: Row 1, Column 2 plus Row 2, Column 2 should total 100%.
- Ask the head coaches to review the most updated eligibility or squad lists for their teams. Ask coaches to confirm the names of those individuals who are on the team as of the first **date of competition**, and cross out the names of those who were cut from the team or quit the team prior to the first competitive event. In order to determine the total number of athletics participants, an individual should be counted each time he or she participates on a team. Note: While being within three percent is not a formal compliance standard; if the percent listed in Row 1, Column 4 is within 3% of Row 1, Column 2, then it provides a good target within which compliance is likely.
