D		Other Recommendation and Comments Students in grade 12 should not be surveyed. The survey shows a significant interest in volleyball; however, this is not reflected on test three. The Gender Equity Review Committee should investigate this interest and its feasibility in the girls' program. The purchasing of mats for cheerleading should not be included in the report; cheerleading is not a sanctioned sport and should not be part of this report (see Form T-68). The school submitted Form T-60 (Corrective Action Plan) noting that there were no corrections needed. Noting that the KHSAA had sent the school a letter regarding "prime time" scheduling for girls' basketball, it was noted by the auditor that this was not mentioned on the Corrective Action Plan as an item the school was working to improve. In reviewing the 2002-2003 Corrective Action Plan, school personnel stated that they were adding volleyball in three-year intervals; the follow-up of the progress was not mentioned on the 2003-2004 Corrective Action Plan as well as other items mentioned on the plan. School personnel are requested to review this matter and resubmit Form T-60 to the KHSAA no later than July 30, 2004.

- After reviewing the resubmitted copies of Forms T-35 & T-36, according to the expenditures submitted by school personnel, it appears that approximately \$100 more is spent per athlete in the boys' athletic program. This matter should be discussed and reviewed by school administration and the Title IX Gender Equity Review Committee.
- It was also noted that the exact amount of monies budgeted was the exact amount spent in each sport. The auditor found that to be somewhat unusual.
