Since 35 students indicated an interest in soccer, the school needs to pursue this interest before being able to meet the standard for Test 3. Spending for athletic benefits appears to be within acceptable parameters based on the school's T-35 and T-36. According to information provided on T-35 and T-36, current spending for athletic benefits appears to be within acceptable parameters.
