According to calculations, data, and responses submitted, the school is likely meeting the standard established in both Tests 1 and 3 for the provision of athletic opportunities. In the area of benefits, total athletic spending appears to be barely outside acceptable parameters (approximately \$597 per male athlete and approximately \$479 per female athlete). The school's Corrective Action Plan addresses the current disparity. School officials need to continue to implement the Corrective Action Plan and closely monitor spending until acceptable standards are met.</p>





<p>Expenditures: Ohio County High School has monitored budget allocations in efforts to close the gap between gender expenditures. The total spending for the 2006-2007 school year indicated that 64% of the total budget was use for male sports while 36% was use for female sports. The 2007-2008 spending was 59.6% for boys compared to 40.4% for the girls. The major difference in total spending results from the large budget needed to operate and maintain the football program.
