In the area of benefits, total athletic spending appears to meet the parameters on percentage spending, but is slightly outside the acceptable parameter for per athlete spending. Forms T-35 and T-36 reflect \$0.00 spent in the areas of travel for softball, cross country, golf, and soccer and in the area of awards for golf. This should be addressed by the Gender Equity Committee and reflected on the 2011 Corrective Action Plan. Thank you.




