E.	<input checked="" type="checkbox"/>	Other Recommendation and Comments: According to data and calculations submitted, the school is meeting the standard established in Test 1 for provision of athletic opportunities. The responses on the T-3 form indicated that the standard established in Test 3 is also being met. However, the results submitted for the most recent student athletic interest survey do not seem to support the responses given on the T-3 form. The indicated interest in girls tennis (38) would have to be addressed for validity in order to meet the standard of Test 3. <u>In the area of benefits, total athletic spending is outside of acceptable parameters both on a percentage and per athlete basis.</u> This is the second consecutive year that this disparity has existed. (See T-65 for 2008-09.) <u>Addressing this spending imbalance should be a part of the school's Corrective Action Plan.</u> Minutes from the school's Gender Equity Review Committee meetings should also document the steps being taken to oversee spending for provision of parity in the area of benefits.


