- 1) Determine the total number of girls enrolled, (place in Row 1, Column 1). Determine the total number of boys enrolled, (place in Row 2, Column 1).
- 2) Add the total number of girls and boys enrolled to determine total enrollment, (place in Row 3, Column 1).
- 3) Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by Row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. (Divide Row 2, Column 1 by Row 3, Column 1 and place in Row 2, Column 2.) Note: Row 1, Column 2 plus Row 2, Column 2 should total 100%.
- Ask coaches to confirm the names of those individuals who are on the team as of the first date of regular season competition, and cross out the names of those who were cut from the team or quit the team prior to the first regular season competitive event. Determine the total number of interscholastic athletics participants that are girls, (and place in Row 1, Column 3). In order to determine the total number of athletics participants, an individual should be counted each time he or she participates on a team. Calculate the percentage of male participation. (Row 2, Column 3 divided by Row 3, Column 3 and place in Row 2, Column 4.) Note: Row 1, Column 4 plus Row 2, Column 4 should total 100%.

Note: While being within three percent is <u>not</u> a formal compliance standard, if the percent listed in Row 1, Column 4 is within 3% of Row 1, Column 2, then it provides a good target within which compliance is likely.

Plans to Address Interest: For the past two school years (2008-09 and 2009-10) we have addressed the interest in soccer by offering an intramural program to gauge the interest and to enhance the skill level of students wishing to participate. However, the number of participants have yet to warrant participation in interscholastic competition at any level.

We addressed the interest in swimming by offering individuals to swim competitively during the 2009-10 KHSAA swim season. We had our first ever individuals to swim in the KHSAA regionals. We hope to have enough to enter full teams in next year's tournament.

"Explanation" Form T-41

 Reason the committee found the boys athletic program had an advantage over the girls athletic program:

The Rockcastle County Gender Equity Committee on March 31, 2010 decided the boys' athletic program had an advantage over the female athletic program based upon the difference in the spending. In the past we have been told that the KHSAA gives the school with football an amount of \$100 discrepancy in spending in male athletic programs due to the high cost of equipping football teams. With this in mind and with the difference in spending of male sports in the area of supplies exceeding the \$100 allowable amount, our committee felt the advantage went towards the boys' athletic program. That was the basis for our checking the "Boys' Program" on form T41.

We plan to address what we "determined" as an advantage by the close monitoring of the expenditures between the girls athletic programs and the boys athletic programs, as stated on form T-60, "Corrective Action Plan."

· Reason no awards were given in Track

Other than presentation of a plaque to the graduating seniors last year, our track coaches stated that they gave no awards at the "conclusion of the season." However, the girls track coach purchased a couple of different tee shirts for the members of the girls' squad following the winning of the region last year. The cost of the plaques and tee shirts totaled to be no more than three hundred dollars. The boys team did not have any senior participation on their squad, nor did the team win any meets last year.

Explanation Form T-63

- The report that was submitted on April 14, 2010 shows the number of surveys administered and the number of surveys returned as "905 Surveys and 756 Returned from Grades 8-11." I do not understand what is missing from that portion of the report. That is a return rate of the surveys was 83.6%.
- Data for enrollment: The enrollment at Rockcastle County High School at the end of the second month of school in the 2009-2010 school year was 869 students. We did not survey the seniors of the class of 2010, as they will not be students of our school next year. However, we did survey next year's freshman class (this year's eighth graders) and their input was included in the findings of the survey administered on September 3, 2009.

Explanation "Not Addressing Tennis"

- The interest in Tennis as shown in the results from the student survey has yet to be addressed due to the following reasons:
 - 1. We are still in the process of addressing the interest shown in two other sports, soccer, and swimming. Once we determine that these sports will/will not become interscholastic sport at Rockcastle County High School, we will then begin to address the sport of Tennis.
 - 2. The lack of a tennis facility within our county is another obstacle we must overcome should we attempt to introduce the sport of tennis to our students
