E.	x	<p>Other Recommendation and Comments: According to the data and results submitted, it appears the school is not meeting any of the three standards for the provision of athletic opportunities. The information on T3 is not supported by the results of the student interest survey. There is an indicated interest in volleyball but no written evidence exists for plans to address and it is not reflected in the Corrective Action Plan. To avoid deficiency and to be compliant, schools must meet one of the three test standards. This should be addressed by Administration and the Gender Equity Committee and documented for the 2011-2012 school year. In the area of benefits, total athletic spending is slightly outside the acceptable parameter on a percentage basis but meets the parameter on a per athlete basis.</p>


