Equipment and Supplies	X		Equipment and supplies appeared to be adequate. The boys' and girls' uniforms were of excellent quality. It was recommended that school personnel maintain a written uniform replacement schedule.
Scheduling of Games and Practice Time	X		See comments below regarding scheduling of games. Practice times for athletics teams are alternated on an equitable basis.
Travel and Per Diem Allowances	X		It appears that money spent for meals on away athletics trips ranged from \$5.00 - \$8.00. The audit report indicates that the number of girls away games far exceed boys' away games.
Coaching	X		Salaries for comparable sports appear to be equitable. Also, a number of girls' teams appear to have experienced coaches. It was noted that 25% of boys' coaches are off campus while 40% of girls' coaches are off campus.
Locker Rooms, Practice and Competitive Facilities	X		While school personnel are making improvements to indoor facilities, it appears that some additional improvements may be necessary with respect to outdoor facilities. Future improvements should include upgrading the softball dugouts. It was stated by school personnel that both softball and baseball teams utilize the indoor batting cage.
Medical and Training Facilities and Services	X		It appears that girls' teams have access to the weight room and training room according to information that has been provided. The addition of lighter weights in the weight room for females would be appropriate.
Publicity	X		The Hall of Fame is outstanding for both boys' and girls. School personnel should maintain a policy on the display of banners.

Support Services		Facilities and accommodations for boys' and girls' coaches looked comparable. However, budgeting information was incomplete and school personnel are being requested to provide updated information for the 2001-2002 school year.

(Selection of Cheerleaders) On or before September 1, 2001, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before September 1, 2001, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.

(Improvements to Softball Facility) On of before September 1, 2001, the school is requested to consider additional improvements with respect to its softball facility. In addition to those changes planned, the school personnel should address other differences noted in comparison to its baseball field. The goal should be to make those two facilities as comparable as possible, and included in the Corrected Action Plan.

School personnel are requested to provide no later than **September 1, 2001**, actual budgeting expenditures for each sport for the 2000-2001 school year. (Forms T-35-36) Deficiencies recognized in the submitted document were explained in the audit visit as inaccurate information (i.e. payment for physicals, away game contest comparison, etc). Future reports should reflect accurate information

Overall Apollo High School has very good facilities for boys' and girls' sports. The pictures "shadow boxes" honoring the Apollo High School athletics Hall of Fame members are very attractive and promote the male and female athletes in an excellent fashion. It appears that school personnel are genuinely trying to conduct the athletics program in a fair and equitable manner.
