Accommodation of Interests and Abilities	X		According to the data and calculations, Augusta High School has met the standard for Test 2, the Test of History and Continuing Practice of Expansion. Eight sports have been added during the past 5 years. The data and calculations also showed that the standard for Test 3, the Test of Full and Effective Accommodation of Student Interest has been met. The survey conducted May 27, 2014, had a return rate of 87.6%. The responses did not reflect the need to follow up on new interests for additional sports.
Equipment and Supplies	x		Review of the uniforms showed the quality and quantity for like sports was equitable. There is a uniform rotation/replacement plan based on a four year cycle. An annual evaluation of uniforms is conducted to determine if replacement is needed because of damage. Spending in this area is equitable and within the acceptable range.
Scheduling of Games and Practice Time	Х		Schedules were in the Title IX file for all school sponsored teams and like sports appeared to have an equitable number of events. Schedules for use of shared facilities were in the Title IX file and at the posted respective venues.
Travel and Per Diem Allowances	X		One of the previous audits recommended guidelines be developed for overnight trips. These regulations have been developed and they address all trips including overnights. However, it is recommended that these regulations for overnight trips include more detailed parameters. Presently, the guidelines state that the cost of rooms are paid by the school, and meals are paid by the athletes. In order to ensure parity specific parameters need to be included.
Coaching	х		All head coaches are employed on campus, making access of coaches by athletes very easy. The ratio of coaches to athletes is 7/1 for both genders. Compensation for coaches of like sports is equitable, including

		compensation for assistant coaches. The district salary schedule was detailed. Coaches' evaluation is accomplished by observation during the season and each coach is provided with a very comprehensive athletic handbook as well as access to proper coaches' certification and emergency training.
Locker Room, Practice and Competitive Facilities	X	In the previous audit, one concern was the locker rooms. With only two locker rooms, teams must share. All teams have an equitable assignment to locker room space. The locker rooms have been renovated and provide an environment that is acceptable. The school improvement plan called for visiting team locker rooms be made from two existing rest rooms. These restrooms have been converted to locker rooms for physical education instead. This has decreased the use of the athletic team locker rooms. Storage space for all teams is provided and identified. Another concern in both of the previous audits was with the softball field. The field is a baseball field that is shared by both baseball and softball, but the permanent mound and large outfield was not a viable facility for softball. Because of no possible land for a softball field, accommodations have been made by providing a portable mound for baseball and a portable outfield fence for softball.
Medical and Training Facilities and Services	X	The weight room is a community fitness facility located at the school. The room has top of the line equipment and is very female friendly. There is a schedule for use on file and also posted by the entrance of the facility. It is easily accessible for female athletes. The school does not have an athletic trainer, but local physicians volunteer their services at games. Physicals are provided at school by local physicians. This includes a \$10 reduction in cost for those students getting exams at the scheduled school time.  There is a detailed copy of the Athletic Emergency Medical Action Plan.
Publicity	Х	Augusta High School has one cheerleading squad that cheers at both girls' and boys' basketball games. The band also performs at

		both girls' and boys' basketball games, The AD provides oversight of the band and cheerleaders.  On file are detailed guidelines that ensure parity in publicity spending. Guidelines for earned athletic awards, banner display, and banquets are on file. Only the basketball teams have schedule cards, but all the teams' schedules are posted on the web page, along with pictures of each team. Guidelines are also included for the Hall of Fame and uniform retirement. A very detailed athletic handbook is also provided.
Support Services	X	Augusta High School does not have a Booster Club. In addition to financial support from the Board of Education, each team is required to conduct two fundraisers a year. All funds go into a central fund to be shared by all athletic teams. The AD and Principal provide oversight of athletic purchases.  Overall spending totals for the past two years has shown an average of \$244 per male athlete and \$276 per female athlete. This is well within the generally acceptable range of spending.
