5. Brief Summary/Analysis of The Corrective Action Plan (T-60)

The school has identified deficiencies in the areas of (I) Publicity, (II) Travel and Per Diem Allowances, (III) Locker rooms, Practice and Competitive Facilities and (IV) Medical and Training Facilities and Services. For the most part, the school has outlined appropriate changes to be made in these areas. For example, the school is planning to construct a Wellness Center on campus which will provide appropriate training weight training facilities to its female students. In addition, the school has constructed an on campus softball facility and has plans to continually upgrade this facility over the next 2 ½ years. The school is making other repairs and upgrades to improve other facilities used by female students. To avoid future questions and problems in the area of travel, the school is adopting written policies regarding teams' participation in overnight tournaments. These policies should be supplied to the KHSAA when adopted. Publicity concerns have also been addressed in a timely, appropriate manner.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The school appears to be addressing areas for correction noted by its Gender Equity Committee. However, a significant difference in spending noted for a number of comparable sports (basketball, baseball, and softball).

7. Facility Recommendations or Concerns

The school should document the shared use of the baseball field house by other teams. Also, it appears that the school is making progress regarding improvements to its softball facility. The time frame proposed by the school for further improvements and additions appears to be acceptable.

9. KHSAA To Follow-Up Regarding Corrective Action If Necessary On The Following

- 1. To the extent it has not done so, the school should incorporate its preliminary gender equity findings into its Corrective Action Plan. Specifically the Corrective Action Plan should address the addition of teams for soccer (junior varsity): cross-country and golf. This amended Corrective Action Plan should be provided to the KHSAA on or before **December 15, 2000**.
- 2. On or before <u>December 15, 2000</u>, the school shall identify all teams using the baseball field house, the number of days each year that each team uses the facility and the identity of all persons with access to the facility.
- 3. On or before **December 15, 2000**, the school shall advise the KHSAA if it intends to take action to provide a certified trainer to comparable girls teams. To the extent its answer is in the affirmative, the school shall advise the KHSAA of the action taken to address this issue.
- 4. <u>(Selection of Cheerleaders</u>) On or before <u>December 15, 2000</u>, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If the cheerleaders are selected in such a way as to result in an arguably better (i.e., "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sports (i.e., boys' varsity and girls' varsity basketball games).
- 5. On or before <u>April 15, 2001</u>, the school is requested to submit to the KHSAA its written policy regarding teams' participation in overnight tournaments.

(Prime Time Contest/Girls' Basketball) On or before December 15, 2000, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2000/2001 season. The school should also provide similar information for the 1999/2000 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference
