Accommodation of Interests and Abilities	X		According to the data and information submitted, Bullitt Central has met the standard for Test 1 and Test 3 for provision for athletic opportunities in 2013-2014. Females make up 50% of the total student enrollment and 48% of athletic participants. They are to be commended for the recruitment of female participants. The Title IX file was well organized and contained all relevant materials and policies.	
Equipment and Supplies	X		Uniforms viewed appeared to be of high quality and equivalent in quantity. There was written evidence of a five-year uniform review/replacement policy in place. The athletic director must approve any request for the purchase of uniforms outside the assigned rotation.	
			All other equipment viewed appeared to be equivalent in quality and available for all teams. A two-year expenditure average for equipment and supplies shows approximately \$88 spent per male athlete and \$92 spent per female athlete.	
Scheduling of Games and Practice Time	x		Written plans were present in the Title IX file regarding the scheduling at shared facilities of games and practice that appear to be equitable. In- season sport teams were given priority for use of any facility. The school currently meets the requirement of prime time play in regards to girls' basketball.	

Travel and Per Diem Allowances	X	There was written evidence of a Board approved travel and per diem policy that provided for equivalence and administrative oversight. The policy states all travel plans must be pre-approved by the Board and school administration. Parameters set by the policy include 4 athletes @ \$30 each for housing and \$10 a meal per diem for food. Transportation is provided by school bus, school owned vans, and parents.
Coaching	X	A Board approved salary schedule was viewed that appeared to be equitable for all sports. A review of the number of on-campus and off- campus coaches showed equitable access for male and female athletes. All coaches receive a Coaches Handbook containing athletic policies and are required to attend monthly meetings with the administration. At the end of the school year, the athletic director evaluates all coaches. The current ratio of athlete to coach for both male and female is 11:1.
Locker Rooms, Practice and Competitive Facilities	X	Currently Bullitt Central is in transition due to renovation of the old gym and construction of a new, smaller gym. Written assignments for locker rooms and storage was viewed and appeared to be equivalent to all sports. All coaches are given a map showing current assignments and future assignment for offices and storage. Volleyball and girls and boys basketball practice and compete in the old gymnasium with in-season sports given priority. The softball and baseball complex is well maintained with like amenities. Neither field has lights. Both teams share a hitting cage with an additional one under constructed for

		the softball team. All competitive contests for football and the girls and boy' soccer teams are held in the stadium on campus. Practice for soccer is held at Robey Elementary. Summer soccer practice is held at Frank E. Simon park. The track team practices on campus but due to the poor condition of the track surface, no meets are held at the school. Two tennis courts on campus are well maintained but without lights. The following athletic venues are off campus: Bowling-KenBowl Fairdale Golf-Heritage Hills golf course Swimming-U of L natatorium
Medical and Training Facilities and Services	X	Bullitt Central has an excellent weight facility located on the upper level of the gymnasium. It is equipped with hand weights, bars and machines that are female friendly. A schedule for usage was posted and appeared to be equitable in times for male and female athletes.A training room constructed during the renovation is accessible for all athletes. The school does not have the services of an athletic trainer. Although not a Title IX issue as such, it is a concern dealing with the safety and care of all athletes. It is recommended the athletic director and school administrators investigate the possibility of obtaining services of an athletic trainer.
		Complete and detailed Emergency plans were posted at all athletic venues and present in the Title IX file.
Publicity	х	There was written evidence of an awards policy that included provision for banners on display, senior awards, letters and bars, and end of season banquets. Written guidelines for the assignment of

		cheerleaders and pep band was included in
		the Title IX file and appeared to be equitable for all sports teams.
		Posters with pictures of current sport teams were on display in the school.
Support Services	X	There are seven sport teams at Bullitt Central with Booster clubs. The athletic director meets tri-monthly with Booster clubs to review their financial records for fundraising and expenditures. There is no prior approval by the school administration for booster spending. Equity issues can occur quickly and be significant. Signed agreements were from all booster clubs were present in the Title IX file. Teams with in-house accounts must have prior approval from the athletic director and principal for fundraising events and expenditures. <u>See KHSAA recommendations</u> Total athletic spending over a two-year period appears to be within acceptable parameters for the provision of parity in both percentage and per athlete basis.
